### 1. Call To Order

Matsumoto, due to the absence of Vice Chancellor Ingram, called the meeting to order upon achieving quorum at 1:32 pm.

#### 2. Introductions

No introductions were needed.

### 3. Approval of Meeting Minutes – March 6, 2024 (Action)

A motion made by Diaz was seconded by Clacken to approve the minutes of the March 6, 2024, meeting with one correction to the name of Darlene Diaz. The motion passed unanimously.

### 4. <u>Projects Update</u> (Matsumoto)

Matsumoto screenshared the projects update providing a status report of current projects with the assistance of Joe Melendez. Updates are noted in **blue text** and the presentation is posted on the PRC webpage for ease of review and reference.

#### Major highlights include:

Santa Ana College

- Russell Hall Demolition Project Is under way and slightly behind schedule due to the excessive amount of abatement. Heavy demo will begin at the end of spring semester avoiding conflict with finals and academic schedule. July and August will be the removal of the foundations.
- Campus Entrance Improvement Project DSA approved the plans, and staff are preparing for bid. This phase will follow the demolition work of Russell Hall.
- Miscellaneous secondary projects continue including the reconfiguration of Temporary Village at SAC moving forward with the anticipated award of bid at a future board meeting.
- Centennial Education Center Redevelopment is still under way with the anticipated hiring of an architect.
- Bristol & 17<sup>th</sup> Street feasibility study is complete. Campus is reviewing study closely and the programs associated with the study to potentially scale down the project.
- Other projects include the new synthetic football field and Building K canopy projects.

#### Santiago Canyon College

- Orange Education Center remediation continues with potential for consolidating lease spaces.
- Campus Entrance Improvement Phase 1 is wrapping up. Melendez noted the closure of lots 6 and 7 for final sealcoat and stripping with the reopening on May 13. Then punchwork will then be completed. Phase 2 scope of work is pending review and may be broken up into multiple phases as requested by the college.
- Building D restrooms are finished.

### Scheduled Maintenance - Santa Ana College

- There are various projects in varying stages including the CEC roofing repairs, fire systems and code repairs across the campus, pool work, roof work, and HVAC work.
- Building G will be submitted to DSA for review and approval.

### Scheduled Maintenance - Santiago Canyon College

• There are various projects in varying stages including fire systems and code repairs, and other miscellaneous work being completed.

### Facility Modification Requests, Blazer Settlement, and Current Test Pilots

- MCHS roofing project is now in the pre-construction phase. Staff is working on logistics, contractors' certifications with plans to start work at the end of May.
- Other facility modification requests in varying staging are being worked on.
- Blazer Settlement status was reviewed and discussed. The remaining deficiencies are more difficult to resolve related to Buildings A and B.
- Access Control & Key projects district-wide includes unfunded projects thus the reason for designation "under review" for estimated budget; meaning there are no funds to support the execution of this work.
- Sustainable Master Plan Update is still progressing with goals on track to have plan update in 2025.

Matsumoto discussed on-going planning activities including the Five-Year Capital Construction Plan Update for State Chancellor's Office; this plan is updated every year and must be submitted to Chancellor's Office by July 1. It does not reflect everything in the Facility Master Plan but gives the State an idea of the anticipated costs spent on projects. Potential Bond planning is also forthcoming with a vote by the Board of Trustees in June.

Questions were answered for clarification of information received.

### 5. <u>Colleges' Earth Day Eve</u>nts

Hoffman provided a brief report on the ASG earth day activities at SAC. Satele provided a brief report on the ASG earth week activities at SCC. Both commended staff for support and attendance at their respective events.

#### 6. Sustainability Committee Update

Matsumoto reiterated the committee continues the work to update the plan to align with State goals. The next meeting is May 15. All were encouraged to access the

sustainability survey, by visiting the <u>webpage</u> that includes a scan code and link. The feedback is very much appreciated.

#### 7. Update on Campus Facilities

- SAC Hoffman reported on the activities of the SAC Facilities & Safety
  Committee meeting of April 16, 2024. Topics focused on Russell Hall demolition,
  Facility Master Plan update, Earth Day event, and various maintenance projects.
  Hoffman also introduced Paul Vernola, the new Maintenance Supervisor. Next
  meeting is May 21, 2024.
- SCC Satele reported on the activities of the SCC Facilities and Safety Committee noting a 33-member subcommittee is working on the decommissioning of the U Building, and other topics focused on the roundabout, and phase 2 of campus entrance. She expressed appreciation for the detailed report of leaks/repairs. Next meeting is May 20, 2024.

#### 8. Potential Bond Measure

Information is forthcoming and will be shared with the Board of Trustees.

#### 9. Meeting Schedule

This is the last meeting of the fiscal year. The meeting schedule for 2024-25 was reviewed. A motion made by Hoffman was seconded by Satele to approve the meeting schedule as presented. The motion passed unanimously. The next meeting will be held September 4, 2024,

#### 10. Other

Matsumoto reported minor edits are being made to the Facility Master Plan Addendum 2024, to reflect on-going work since 2022 update and is forthcoming. The Five-Year Capital Plan is forthcoming and differs from the potential bond project list. In May, staff will attend meetings at both campuses to discuss these updates.

There were no further questions or concerns expressed.

### **Project Summary:**

- Construction of a new 55,563 square foot Health Sciences Building to include Nursing, Occupational Therapy Assistant, Emergency Medical Technician, Pharmacy Technology, and 20 general classrooms and computer labs. New building will be located south of the existing library and north of the new Science Center
- Demolition of existing Russell Hall Building

#### **Current Status:**

- Project reached final completion on November 30, 2023.
- Notice of Completion approved by the Board of Trustees on December 11, 2023.
- The College held a Grand Opening event on January 10, 2024.

### **Budget:**

- \$58.8 million (budget under review) includes demo budget
- \$19,707,000 state funded (2023 estimated contribution) includes demo budget






## Current Capital Projects Russell Hall Demolition Logistics Plan Alternate Campus Entrances & Vehicular Routes

### **Project Summary:**


- Campus Entrance Improvement project Phase 1 is scheduled to start upon completion of Russell Hall Demolition project anticipated October 2024. Project objectives include traffic congestion reduction, improve pedestrian and vehicle circulation, remove accessibility barriers, increase bus/rideshare drop-offs, and improve the campus front entry.
- In an effort to minimize college impacts and provide flexible construction budget options, project will be phased into three (3) phases.
- Phase 1: front entry renovations, softscape and hardscape improvements, introduction of a new "hairpin" vehicular turn, shade structure and front entry plaza improvements.
- Phase 2: Parking Lot # 1 renovations with hardscape and softscape improvements and increased parking stalls counts.
- Phase 3: Parking Lot # 3 and # 4 renovations with hardscape and softscape improvements, increased parking stall counts, increased drop-off areas, and dedicated ride-sharing areas.
- All phases will improve traffic and pedestrian circulation & safety and remove accessibility barriers.


#### **Current Status:**

- Award of bid for the contractor for Phase 1 was approved by the Board of Trustees on August 12, 2024.
- Construction is anticipated to start in October 2024 after Building R is demolished.

### **SITE PLAN: Preferred Concept**





## Current Capital Projects Orange Education Center Site Remediation & Redevelopment Santiago Canyon College

### **Project Summary:**

- While undertaking a redevelopment design option to upgrade building to meet DSA building code standards, underground soil vapor contamination was discovered. Historical data revealed existing building resided on a site that was previously used for industrial business use.
- As a result of newer environmental regulations and to meet Orange County Health Department requirements for commercial clean-up standards, building was demolished March 2020 in order to clean up soil vapors on the property.
- The District and College are exploring options of potential development of the 'non-impacted' area of the site that occur within a target budget of available funds.

### **Current Status:**

- The Air Quality Management District has approved a revised permit. The M&O contractor restarted the equipment in February 2024 and site remediation will continue.
- Exploring various development options.
- Working on a short-term lease of site during remediation.

### **Budget: Under Review**

\$25 million remaining in Budget



- Phase 1: construction of a new roundabout and drop off east of the Library, between parking lot 6 and the East Chapman entry, which is in alignment with the Campus Facility Master Plan.

### **Current Status:**

- The Notice of Completion was approved by the Board of Trustees on August 12, 2024.
- Secondary projects:
  - Parking lot #6 will be slurry coated and restriped- Anticipated around September 2024.
  - Barrier rails will be installed to deter vehicles from running off the curb near the new water retention basin - In design.



- Allocation for Scheduled Maintenance and Instructional Equipment from the State is \$7,651,534. All funding will be allocated to Scheduled Maintenance only. The original allocation was \$18,882,875, a reduction of \$11,231,341 due to State budget reductions.
  - The allocation for 23/24 is \$128,753. The allocation is \$87,553 for SAC and \$41,200 for SCC. All funding for 23/24 is to be utilized for SM 23 projects due to shortfall in budgets. Total SM23 allocation is \$7,780,287.
