#### 1. Introductions

#### 2. Sustainable RSCCD Committee Purpose and Responsibilities

Ms. Matsumoto shared the Sustainable RSCCD Committee Purpose and Responsibilities and asked the committee if they had any questions, comments or edits. There were no changes.

#### 3. Sustainable RSCCD Committee Membership

Ms. Matsumoto shared the proposed Sustainable RSCCD Committee Membership as of 2024 and asked the committee if they had any questions, comments or edits. There were no changes. She noted there is a vacancy for a CSEA representative from Santa Ana College.

## 4. Meeting Notes of May 15, 2024

Ms. Matsumoto noted the meeting notes from the May 15, 2024 meeting were attached to the agenda for today's meeting and asked the committee if they had any questions, comments or edits. There were no changes.

## 5. Biennial Report Covering FY24-25

Ms. Matsumoto noted we will share a draft of the biennial report with the committee in the new calendar year. Mr. Curiel noted the google doc was shared with the colleges and thanked the colleges for the updates that have been provided.

## 6. 2024 Sustainability Survey

Mr. Curiel shared the preliminary employee results of the 2024 Sustainability Survey. There were 160 responses and the survey is still open. There weren't any student responses. Ms. Matsumoto asked if committee members from the colleges would like to share the survey with students to gather more data or if the data we have is sufficient. Ms. Satele noted she would talk to ASG about the survey. Mr. Hoffman noted the data already collected is sufficient.

### 7. Future Update to Sustainability Plan 2025

Ms. Matsumoto shared the draft Sustainability Plan. Ms. Imai noted the changes between the 2015 RSCCD Sustainability Plan versus the 2025 draft RSCCD Sustainability Plan. The new Sustainability Plan and Sustainability biennial reports will be more aligned. Ms. Matsumoto noted the Sustainable RSCCD Committee can make updates to the plan as needed even though it may not align with the District's Comprehensive Master Planning cycle. The draft plan will be shared with both college's Facilities & Safety Committee meetings in October and the Physical Resources Committee meeting in November. A zoom townhall will be scheduled for attendees to provide feedback on the draft plan.

#### 8. Sustainable RSCCD Committee Field Trips

Mr. Curiel noted that possible field trips for the committee would be to visit the Orange County Water Districts' Groundwater Replenishment System in Fountain Valley or CR&R in Stanton or Perris. Ms. Matsumoto noted an e-mail can be sent out to the committee to get input on which field trip they would prefer to go to and possible date options.

#### 9. College Updates

Ms. Satele noted SCC is working with CR&R to get more food waste pickups.

Mr. Hoffman noted SAC is going to have meeting about the CR&R food waste recovery program in a few days.

### 10. Other

Ms. Matsumoto asked the committee if they had any other items for discussion, questions or comments. There were none. Ms. Matsumoto thanked the committee for their participation.
