Placement on Salary Schedules

New unit members shall be placed on the first step of the appropriate class. Advancement to the next step shall occur upon completion of three (3) semesters of service. A semester of service means that a unit member teaches at least 75% of the semester length. Time worked as a substitue, summer school unit member, site administrator or in the credit program shall not count toward step placment. Unit members who possess at least 30 semester units beyond the Master's Degree will be placed on MA+30 column effective on the first day of the semester following the submission of official transcripts to the District documenting the coursework.
