Minutes

Mr. Didion called for a motion to approve the Planning & Organizational Effectiveness minutes of March 26, 2014. It was moved by John Zarske, seconded by Rudy Tjiptahadi and carried unanimously to approve the minutes.

District Resource Augmentation Requests

A number of revisions to the resource request prioritization request form were made:
