All subcontractors shall submit completed questionnaires and financial statements **no later than July 17, 2020** and in accordance with the instructions in the Prequalification Package. The successful contractor shall be required to furnish a 100% Performance Bond and a 100% Payment Bond if it is awarded the contract for the Project. In addition, the successful contractor and its subcontractors shall pay all workers on the Project not less than the general prevailing rate of per diem wages and are subject to the District's Community and Student Workforce Project Agreement ("CSWPA").
