BP 3406 - Sustainable Practices

Legal Reference: AB 939

The Rancho Santiago Community College District holds sustainability to be a foundational principle in its current and future development. As a responsible steward of natural resources and the environment, the District will endeavor to minimize its impact on the environment by implementing best practices for conserving resources, reducing waste, implementing energy reduction and alternative energy generation strategies, constructing efficient buildings, and by developing partnerships that will further these activities.

The Board of Trustees delegates authority to the Chancellor to establish administrative regulations for sustainable practices in the following areas: Environmental Education and Training, Energy, Waste Management and Recycling, Resource Conservation, Facilities, Grounds and Landscape Management, Hazardous Materials, Transportation and Air Quality, and Purchasing Practices.

Sustainable RSCCD Committee

Purpose

The Sustainable RSCCD Committee is a participatory governance committee, working with the campus committees, responsible for raising awareness within the district and making recommendations to the Chancellor concerning the conservation of energy and other resources and the implementation of sustainability practices that impact the district and community.

Responsibilities

- Promote and nurture new patterns of thinking about college and district operations, practices, learning programs, support services and the relation to the local community that include consideration of conservation of energy and sustainability.
- Develop a comprehensive plan to achieve climate neutrality.
- Create institutional structures and identify resources relating to conservation of energy and sustainability to guide and support the implementation of the comprehensive plan.
- Complete an inventory of all greenhouse gas emissions and update that inventory at least once every two years.
- Encourage the development of curriculum that raises awareness about climate neutrality and sustainability and that offers a career path to employment in "green" technologies.
- Review the status of and develop objectives related to improving and maintaining the "green infrastructure" of the district and colleges.
- Provide periodic progress reports on the accomplishments of the committee.

Re RSCCD Sustainability Planning Process

Following our meeting with your Sustainability Committee we have drafted a three-step sustainability planning process:

STEP 1 - ANALYZE

- Collect and review information provided by district (energy use, water use, waste hauling/recycling, student and faculty commuting/zip code information).
- Analyze existing conditions at each RSCCD site that relate to sustainable facilities and operations.
 - o Environmental and climate
 - Analyze and define factors
 - Carbon footprint
 - Define current baseline and trending carbon footprint for each site

Workshop #1

- Present Analysis:
 - Environmental and climate analysis
 - Carbon footprint analysis
- Define expectations—short-term and-long term objectives for the sustainability planning process.
- Review CC template and RSCCD nine focus areas (as identified in BP-3406 Sustainable Practices policy).
- Coordinate development of draft strategies
 - Determine next steps and homework assignments

STEP 2 - EXPLORE

Workshop #2

- Share researched strategies.
- o Identify sustainable strategies to pursue in the nine focus areas.
- Prioritize the strategies for each RSCCD site.



STEP 3 - RECOMMEND

- Develop recommended strategies and objectives
- Define projects to implement at each site
- Workshop #3
 - o Present strategies and proposed recommendations
- Develop draft sustainability plan
- District review and comment
- Finalize the Sustainability Plan document

DELIVERABLE: RSCCD Sustainability Plan

RSCCD Responsibilities:

- Identify RSCCD sites to be included in the sustainability plan.
- Identify stakeholders to represent each site at the Workshops #1 and #2.
- Provide energy use, water use, waste hauling/recycling, student and faculty commuting/zip code information for the last three years.
