According to the Foreign Trade Division, U.S. Census Bureau, the Mexico-California commercial relationship was worth approximately \$20.5 billion in 2008.

"Trade with Mexico offers tremendous opportunities for Orange County companies," said Enrique Perez, director, CITD. "It's vital that businesses here stay on top of current and emerging potential for growing business through international trade."
