Ms. Matsumoto shared a presentation on the parking at Santa Ana College (SAC) that was presented to the SAC Facilities Committee. Their parking analysis showed that there is decreased demand for parking from 2014-2017 and that the current parking supply is sufficient to meet demand. There will be the need to have contractor parking on the lot at 17th and Bristol during the upcoming periods of high volume construction. The SAC Facilities Committee will be conducing follow up discussions about parking at a future meeting.
