MINUTES

1.0 PROCEDURAL MATTERS

1.1 Call to Order

The meeting was called to order at 4:36 p.m. by Mr. John Hanna. Other members present: Mr. Larry Labrado. Other board member present: Mr. Ryan Ahari.

Staff present: Mr. John Didion, Dr. Raúl Rodríguez, and Ms. Anita Lucarelli as record keeper.

1.2 Pledge of Allegiance to the United States Flag

The pledge of allegiance was led by Mr. Ahari.

1.3 Public Comment

1.4 Approval of Minutes

It was moved by Mr. Labrado, seconded by Mr. Ahari, and carried unanimously to approve the minutes of May 10, 2012.

2.0 <u>REVIEW OF BOARD POLICIES & RELATED ITEMS</u>

2.1 Review of BP 9022 - Board of Trustees Self-Evaluation

The committee discussed the self-evaluation instrument and list of individuals who will receive a copy of the instrument. Since there were no requests from board members, staff, or the college community to modify the self-evaluation instrument or list of individuals who receive a copy of the instrument, the committee recommends that the full board use the same self-evaluation instrument used in prior years. It was noted that using the same instrument would ensure consistency in data comparison from one year to the next.

2.2 Review of BP 9002 - Statement of Ethical Conduct

The committee reviewed BP 9002 since there had been a structural change this year in the electoral process (going from 3 districts with at-large voting to 7 individual areas and voters in each area voting for a trustee). The committee did not recommend changes to the policy, but for accreditation purposes, it was determined that the full board should be reminded of this section of the policy: "Trustees are elected to represent the interests and serve the needs of the entire district and to promote the mission of RSCCD." It was also noted that the board will review and approve this policy at its annual organizational meeting in December and new board members will be given an opportunity to review/approve it at that time.

The committee reviewed the following policies. After discussion, the committee recommended the following changes (in italics) be made before bringing the policies to the full board for a first reading:

<u>BP 2010 Board Membership</u> – *The Board of Trustees may change the methodology utilized for electing Board members in any manner consistent with the law.*

BP 2015 Student Member - The student member shall be entitled to any mileage allowance necessary to attend board meetings *and reimbursement for travel (see BP 2735)* to the same extent as publicly elected trustees.

BP 2100 Board Elections – Include link to map and legal description if possible and replace last sentence with this one: *The Board Policy Committee shall meet following each decennial federal census and, in conjunction with the Chancellor, shall recommend to the Board any adjustments to each trustee area. There will not be an adjustment of trustee area boundaries between decennial censuses unless the district acquires or loses territory.*
