## 2.1 Board Goals

Board members and staff discussed and developed goals in the following areas:

### 1. Bachelor's Degree Program

#### GOAL

- 10 Bachelor's Degree Programs by 2030
- 3 bachelor's Degrees from each college
- 1 bachelor's degree per year

### 2. Apprenticeship Programs

#### GOAL

- SAC: 4 additional apprenticeship programs in the next 3 years
- SCC: 9 additional apprenticeship programs in the next 3 years

### 3. Transfer & Completion

#### SCC Transfer Goal

- 4.2% increase for the next 3 years
  - ◆ 1% increase 2025-26
  - ◆ 1.4% increase 2026-27
  - ◆ 1.9% increase 2027-28

#### SCC Completion Goal

- 4.2% increase over the next 3 years
  - ◆ 1.2% increase 2025-26
  - ◆ 1.4% increase 2026-27
  - ◆ 1.6% increase 2027-28

#### SAC Transfer Goal

- 13% increase in the next 5 years

#### SAC Completion Goal

- 13% increase in the next 5 years

### 4. Enrollment

FTS Districtwide is about 31,000

- SAC – 22, 000 FTS
- SCC – 9,000 FTS

Board agreed that no goals will be set for enrollment at this time due to the CAP.
