#### Minutes

#### **Update on Annual Progress Report on Comprehensive Master Plan**

Research Director Nga Pham reported that updates on the Comprehensive Master Plan are almost completed. There are some areas that responses still need to come in. A draft should be ready for review by the POE committee when they meet in November. The goal of the committee is to have an update ready and presented at the January 2015 board meeting.

#### **General Review of 2014-15 Planning/Budgeting Cycle**

The committee reviewed two documents from the Fiscal Resource Committee as well as an annual planning calendar that summarized some of the key milestones and deadlines each month that are in the planning design manual. This led to discussions on what the POE committee thought worked or didn't work both at the district level and at the colleges. After discussion, it was apparent that the role of the five committees needs to be clarified. Suggestion was made that a planning retreat with all the committees needs to be held and that this recommendation be brought up at the next District Council meeting.

#### **Grant Development Schedule**

Assistant Vice Chancellor of Educational Services Enrique Perez reported that five grants were submitted with an expected notification date in early 2015. Discussion ensued regarding institutionalization.
