1. <u>Approval of Minutes of June 5, 2017</u>

It was moved by Dr. Hernandez, seconded by Mr. DeCarbo and carried unanimously to approve the minutes of the June 5, 2017 meeting.

- July 17, 2017 Board of Trustees Meeting Vice Chancellor Hardash shared highlights of the agenda for the July 17, 2017 Board of Trustees Meeting.
- 3. 2017-2018 Adopted Budget Assumptions

Vice Chancellor Hardash presented the 2017-2018 Adopted Budget Assumptions, which were unanimously recommended by the Fiscal Resources Committee for District Council approval. Discussion took place about the source of funding for the estimated \$2 million required for ADA projects. An alternative suggestion to fund this work with 2017-2018 scheduled maintenance funds rather than the one-time budget reductions was considered. It was moved by Mr. DeCarbo, seconded by Dr. Mettler and carried unanimously to accept the 2017-2018 adopted budget assumptions dated June 28, 2017 as recommended by the Fiscal Resources Committee pending further review and evaluation as per the participatory governance process relating to the funding of the ADA projects.

4. <u>Reorganizations</u>

Interim Vice Chancellor Chitlik presented two reorganizations for consideration:

- a. Information Technology Services: it was moved by Dr. Kennedy, seconded by Ms. Stapleton and carried unanimously to approve reorganization #1034.
- b. Educational Services: it was moved by Ms. Stapleton, seconded by Dr. Kennedy and carried unanimously to approve reorganization #1035.
- 5. Board Policies/Administrative Regulations

Vice Chancellor Perez presented the following board policy and administrative regulations revised as recommended by CCLC:

- a. BP/AR 6307 Debt Issuance and Management (NEW): the board policy will be presented for a first reading at the July 17, 2017 board meeting; the administrative regulation will be brought back to District Council for approval after board approval of the board policy
- b. AR 6300 Fiscal Management
- c. AR 6450 Wireless or Cellular Telephone Use
- d. AR 7400 Travel

It was moved by Ms. Chitlik, seconded by Mr. Hou and carried unanimously to approve AR 6300, AR 6450 and AR 7400 as presented.
