# 1. Participatory Governance Issues

#### 3. Student Success Task Force Recommendations

Chancellor Raúl Rodríguez reported that he received feedback regarding the Task Force recommendations from the students and faculty. This information will be shared with the Board at the December 5, 2011 meeting. Because it may be difficult to come to consensus with respect to a district response in time to have an effect on the report, a recommendation will be made to the Board that no district position be taken and the feedback received be forwarded directly to the State Chancellor's office for their consideration.

## 4. Participatory Governance Review

The District and College Participatory Governance and Planning-Budget Processes flowcharts were presented for endorsement by District Council. The charts presented had been reviewed by Chancellor's Cabinet and revised as necessary. There was a question raised about the Planning-Budget Processes flowchart and President Vázquez committed to investigate and provide correction to the chart if necessary. Both flowcharts were endorsed by District Council, with the correction if required on the Planning-Budget Processes flowchart.

## 5. Rancho Innovation and Sustainability Committee (RISC)

The description for the Rancho Innovation and Sustainability Committee (RISC) was presented and endorsed by Council members. Chancellor Rodríguez requested constituent group representatives make their appointments to this committee, so that a meeting of the Committee can be held in spring 2012.
