BACKGROUND

In accordance with the California Code of Regulations, Title 5, Sections 58305(d), the District shall submit a copy of its certified Annual Financial and Budget Report (CCFS-311) to the Chancellor's Office by October 10th of each year. Furthermore, in accordance with Article XIIIB to the State Constitution, limitations on expenditures are placed on State and local governments in the form of what is known as the Gann Appropriations Limit.

ANALYSIS

A copy of the CCFS-311 Report has been provided for your review. The CCFS-311 Report is divided into three parts: Current Expense of Education which is used to calculate the 50 Percent Law (our District is in compliance at 50.18% for 2011/12); Combined Balance Sheet information for all District funds; and other Supplemental Data including Details of General Fund Revenue, General Fund Expenditures by Activity, the Gann Appropriations Limit (Historically, our district has never met or been close to meeting the appropriations limit), Revenues, Expenditures and Fund Balance Data for all district funds, an Analysis of Interfund Transfers, and the Receipt and Expenditures of Lottery Proceeds.

RECOMMENDATION

It is recommended that the Board of Trustees approve the 2011-2012 CCFS-311 Report as presented pending any audit adjustments and establish the District's 2012-2013 Gann Limit in the amount of \$214,573,297.

BACKGROUND;

Bernards Management Services is currently providing construction management services for multiple projects at Santa Ana College.

ANALYSIS:

The original contract with Bernards Management Services was project specific, however a number of projects have been assembled from Master Planning project development that require Bernards CM contract to be extended. As outlined in the attached proposal, an aggressive construction schedule has been created to meet the 2015/2016 Centennial celebration. The proposed additional fees for management services are to supplement the construction management team through the completion of the Soccer Field and Road Alignment project and to manage the upcoming Perimeter Site Improvement project.

Costs and timelines have been reviewed to be accurate from past experience and demonstrate regard for the campus academic calendar. The hourly fees remain unchanged from the 2011 Request for Proposal (RFP) and the Board approved Award of Contract at the September 12, 2011 Board meeting.

This Aerial to Underground Conversion Agreement ("Agreement") is by and between Rancho Santiago Community College District, a California corporation ("Applicant"), and Pacific Bell Telephone Company, a California corporation, dba AT&T California ("AT&T"), collectively the ("Parties").

I. DEFINITIONS.

- A. The term "Tariff" refers to Schedule Cal. P.U.C. No. A2, Rule 32(A)(3).
- B. The term "Underground Supporting Structure" (hereinafter "USS") includes, but is not limited to conduit, inner duct, manholes, service boxes and related equipment.
- C. The terms "Trench" and "Trenching" include, but are not limited to, excavating, backfilling, compacting, and as necessary, breaking and replacing pavement, sidewalks, driveways, curbs and gutters; and restoring all other surface features, disturbed by underground construction, including landscaping, plus the cost of performing such work.
- D. The term "Hazardous Substance" refers to any substance, material or chemical that is or becomes regulated under applicable local, state, or federal law, regulation, or ordinance.
- E. The term "District" refers to the area in/on/along the south side of 17th Street just west of College Avenue where the undergrounding of existing aerial facilities is to take place.
- F. The term "Project" means all of the work required to underground existing aerial facilities within the District.
 - G. The term "CPUC" refers to the California Public Utilities Commission.

II. RECITALS.

- A. Applicant has asked AT&T to replace its existing aerial communication facilities within the District with underground communication facilities.
- B. To facilitate this request, Applicant is willing to construct the USS along the public way and upon utility rights of way to AT&T and thereafter transfer ownership of it to AT&T.
- C. AT&T is willing to underground its existing aerial communication facilities within the District, subject to the terms and conditions of this Agreement.

In consideration of the above, the Parties agree as follows:

III. SPECIFIC PROVISIONS.

- Tariff. The Project will be conducted in accordance with the Tariff.
- B. Construction.
- Within sixty (60) days of receipt of a copy of this Agreement that has been executed by Applicant and the advance payments required by Section III (F), AT&T shall provide to Applicant detailed plans and specifications for the Trenching and construction of the USS ("Trenching Plans") Upon receiving the Trenching Plans, Applicant shall submit any questions, concerns, or requests for clarification to AT&T.
- Applicant shall be responsible for Trenching (including sand shading, backfilling, and compaction) and the construction and installation of the USS, which shall be in accordance with AT&T's plans and specifications. Accordingly, Applicant shall, at Applicant's expense, provide all labor and material necessary to construct the USS, including the conduit material and manholes. Conduit material includes: cast steel manhole frames and covers, precast concrete conduit, plastic conduit - type C; fiber cement conduit- type C; steel pipe of equivalent standard heavy-wall duct material acceptable to AT&T, and all associated castings, bends, fittings, and unions. Applicant may, at is sole discretion, make any and all necessary hires to complete the Trenching and may hire any third party it deems necessary to complete the Trenching. AT&T acknowledges that Applicant may be required to follow applicable state law when hiring for work pursuant to this Agreement and AT&T will cooperate with the Applicant in ensuring compliance with all applicable laws. APPLICANT SHALL NOT DEVIATE FROM AT&T'S TRENCHING PLANS AND SPECIFICATIONS WITHOUT AT&T'S PRIOR WRITTEN CONSENT. HOWEVER, IF AN ISSUE ARISES DURING THE TRENCHING, THE PARTIES SHALL WORK TOGETHER IN GOOD FAITH TO RESOLVE THE ISSUE AND MAKE ALL REASONABLE EFFORTS NECESSARY TO REDUCE THE TIME AND COST ASSOCIATED WITH THE TRENCHING. AT&T SHALL NOT UNREASONABLY WITHHOLD ITS APPROVAL OF ANY PROPOSED MODIFICATION TO THE TRENCHING PLANS AND SPECIFICATIONS MADE BY THE DISTRICT.
- Trenching and construction and installation of the USS shall conform to 3. the construction specifications of the City or County that has jurisdiction over the Project. AT&T shall ensure its Trenching Plans comply with all laws, rules and regulations applicable to the Project.
- Within fifteen (15) days of completion of the USS and a time and location of the Applicant's choosing acceptable to AT&T, Applicant shall, in AT&T's presence, prove the integrity of the installed duct structure by pulling a mandrill through each conduit section between the manholes/splice boxes.
- 5. Applicant shall provide to AT&T final footages of conduit sections on an "as built" drawing prior to AT&T's conversion of the aerial communication facilities.

- 6. Applicant shall obtain all permits necessary for excavation from the public agency(ies) that have jurisdiction over the Project.
- 7. Applicant shall diligently work with all affected property owners served by the aerial facilities to be replaced within the District to allow for the maintenance of the USS on their property.
- 8. If, during AT&T's involvement on the Project, any AT&T employees, subcontractors, or agents encounter Hazardous Substance(s) that may be disturbed by AT&T's activities:
- a. AT&T shall give prompt verbal and written notice of the discovery of the Hazardous Substance(s) to Applicant and cooperate with Applicant in any way reasonably necessary to address the Hazardous Substance(s).
- b. AT&T shall suspend performance under this Agreement until (1) containment and removal of the Hazardous Substance(s) have been completed and approved by the appropriate governmental agency(ies) if such approval is required or approved by AT&T, if governmental agency(ies) approval is not required; or (2) Applicant reasonably demonstrates that the Hazardous Substance will not be disturbed by AT&T's activities. If AT&T decides to continue with the performance of this Agreement upon discovering potentially Hazardous Substances, it shall indemnify the Applicant from any damage it suffers as a result in accordance with Section H(3) of this Agreement;
- c. AT&T's performance of its obligations under this Agreement is extended for the amount of time that it takes to complete containment/removal of the Hazardous Substance(s); and
- d. If Applicant elects not to remove/contain the Hazardous Substance(s), AT&T may terminate this Agreement without further liability by giving advance notice to Applicant no later than ten (10) days after the date the Applicant notifies AT&T of its decision not to remove/contain the Hazardous Substance(s). If AT&T terminates this Agreement in accordance with this Section, Applicant shall reimburse AT&T for the costs AT&T incurred prior to the effective date of termination.
- C. <u>Term</u>. This Agreement is effective upon execution and shall continue in effect until terminated or canceled as provided by law or this Agreement.
 - D. <u>Inspection and Acceptance</u>.
- 1. An AT&T Inspector will be provided at the job site during the construction phase of the Project to ensure that all Trenching activities and placement of conduit and manholes/splice boxes are in accordance with AT&T's plans and specification. Applicant shall notify AT&T's Construction Coordinator on (714) 237-6947 forty-eight (48) hours in advance of the start of construction to coordinate the inspection activities.

- 2. AT&T shall have the right to inspect and accept the USS prior to placing any communication facilities therein. When AT&T accepts the USS, it shall prepare, execute, and provide to Applicant a Certificate of Acceptance. Applicant shall submit a written request to AT&T to inspect the USS and request that AT&T issue a Certificate of Acceptance. If AT&T does not issue a Certificate of Acceptance after inspecting the USS, it shall issue a written report to Applicant stating the reasons for non-acceptance and shall cooperate with the Applicant in good faith to address the issues in the written report. Upon issuing a Certificate of Acceptance, AT&T accepts the USS and all Trenching on an "as-is" basis and shall not request any further trenching work from the Applicant except in cases of emergency or unforeseen circumstance.
- E. <u>Placement of Facilities</u>. AT&T will place all cables, wires and associated equipment for the conversion of aerial communication facilities to underground after the completion and acceptance of the USS. AT&T and any other USS occupant shall jointly determine the dates and sequence of construction of each of their respective facilities in the USS. AT&T shall inform the Applicant after the agreement is signed and payment is received when it plans to be on the applicant's Property and when it plans to complete all work. The Parties shall work in good faith to address any scheduling problems.

Applicant shall provide fifteen (15) working days advance notice to AT&T prior to the start of Trenching to ensure AT&T has adequate time to order materials and coordinate the placement of its facilities. After such advanced notice, AT&T shall be solely responsible for coordinating the Project within the time frame set forth in AT&T's schedule.

F. Payment.

1. Applicant shall pay to AT&T within thirty (30) days after execution of this Agreement the sum of \$7,263.49, which represents the estimated cost of converting the aerial facilities to underground, less the estimated net salvage value of the replaced aerial communication facilities ("Advanced Payment"). If applicable, Applicant shall also pay to AT&T a 0% tax component of 0 collected for Federal and State Income Tax in accordance with CPUC decision 87-09-026. These amounts are valid for only sixty (60) days and are therefore subject to change after 10/23/12 (i) if Applicant has not signed this Agreement by that day, and (ii) if applicant has not completed construction within 120 days of that date.

2. Applicant shall pay for the conversion of aerial to underground facilities project on an "Actual Cost" basis. Upon completion of the Project, AT&T will compute the Actual Cost of the Project and shall reimburse the Applicant for any amount paid in excess of the estimated cost. If the estimated cost paid by the Applicant was less than the Actual Cost incurred

by AT&T, the Applicant shall pay to AT&T the difference in the cost at the conclusion of the Project. However, AT&T shall notify the Applicant in writing if the Actual Cost incurred rises above \$75,000.00.

G. <u>Cancellation, Modification or Deferment</u>. If Applicant cancels, modifies or defers its request for the conversion of the aerial facilities to underground facilities within the District, Applicant shall pay any and all charges incurred by AT&T, in accordance with the Tariff, up to the date Applicant notifies AT&T of cancellation. If Applicant requests a modification to the Project, AT&T will reasonable cooperate in good faith with Applicant to accommodate the modification. If the Parties cannot reach a mutually acceptable modification to the Agreement, either Parties will have the option to terminate the Agreement under Section IV(C) below.

H. <u>Indemnity</u>; <u>Limitation of Liability</u>.

- AT&T and its officers, agents and employees, as well as its associated and affiliated companies and their respective officers, agents, and employees ("Indemnities"), from and against any and all losses, damages, expenses, costs, penalties, fines, fees (including reasonable attorney's and consultant's fees), or liabilities (collectively "Liabilities"), incurred as a result of any injury to or death of any person(s), or damage to any property(ies) arising out of or in connection with the materials used or the work performed by Applicant under this Agreement or the condition of the Project's property, including environmental contamination (except for those particular Hazardous Substance(s) addressed between the Parties pursuant to Section III(B)(8) above, except where such Liabilities are caused by the sole negligence or willful misconduct of Indemnities.
- 2. AT&T shall notify Applicant within a reasonable time of any written claims or demand against AT&T for which Applicant is responsible under this Section. Applicant shall also (a) keep AT&T fully informed as to the progress of such defense, and (b) give AT&T, at its own expense, an opportunity to participate with Applicant in the defense or settlement of such claims, demand, lawsuits or other legal proceedings.
- 3. AT&T shall indemnify at Applicant's request, defend, and hold harmless Applicant, and its officers, agents and employees, as well as its Board of Trustees ("from and against any and all losses, damages, expenses, costs, penalties, fines, fees (including reasonable attorney's and consultant's fees), or liabilities (collectively "Liabilities"), incurred as a result of any injury to or death of any person(s) or damage to any property(ies) arising out of or in connection with AT&T's installation of facilities in the USS, work on the Project, or involvement with the Applicant, except where such Liabilities are caused by the sole negligence or willful misconduct of Applicant. Applicant shall notify AT&T within a reasonable time of any written claims or demand against Applicant for which AT&T is responsible under this Section.
- 4. These indemnities shall survive the termination or cancellation of this Agreement or any provision to the contrary herein.
- 5. IN NO EVENT WILL EITHER PARTY BE LIABLE TO THE OTHERFOR INCIDENTAL, SPECIAL, INDIRECT, PUNITIVE, OR CONSEQUENTIAL

DAMAGES, WHETHER BY TORT OR CONTRACT, INCLUDING LOST REVENUES, LOSS OF PROFITS OR OTHER COMMERCIAL OR ECONOMIC LOSS ARISING OUT OF THE PERFORMANCE OF THIS CONTRACT.

I. Insurance.

- a. With respect to Applicant's performance under this Agreement, and in addition to Applicant's obligation to indemnify, Applicant shall at its sole cost and expense, maintain the insurance coverages and limits required by this Section and any additional insurance and/or bonds required by law:
- b. at all times during the term of this Agreement and until completion of all work associated with this Agreement, whichever is later; and
- c. with respect to any coverage maintained in a "claims-made" policy, for two (2) years following the term of this Agreement or completion of all work associated with this Agreement, whichever is later. If a "claims-made" policy is maintained, the retroactive date must precede the commencement of work under this Agreement;
- 2. Applicant shall also require each subcontractor who may perform work under this Agreement or enter upon the work site to maintain coverages, requirements, and limits at least as broad as those listed in this Section from the time when the subcontractor begins work, throughout the term of the subcontractor's work and, with respect to any coverage maintained on a "claims-made" policy, for two (2) years thereafter;
- a. procure the required insurance from an insurance company eligible to do business in the state or states where work will be performed and having and maintaining a Financial Strength Rating of "A-" or better and a Financial Size Category of "VII" or better, as rated in the A.M. Best Key Rating Guide for Property and Casualty Insurance Companies, except that, in the case of Workers' Compensation insurance, Applicant may procure insurance from the state fund of the state where work is to be performed; and
- b. deliver to AT&T certificates of insurance stating the types of insurance and policy limits. Applicant shall provide or will endeavor to have the issuing insurance company provide at least 30 days advance written notice of cancellation, non-renewal, or reduction in coverage, terms, or limits to AT&T. Applicant shall deliver such certificates:
 - i. prior to commencement of any work;
 - ii. prior to expiration of any insurance policy required in this

Section; and

iii. for any coverage maintained on a "claims-made" policy, for two (2) years following the term of this Agreement or completion of all work associated with this Agreement, whichever is later.

3. The Parties agree:

- a. the failure of either Party to demand such certificate of insurance or failure of either Party to identify a deficiency will not be construed as a waiver of the other Party obligation to maintain the insurance required under this Agreement;
- b. that the insurance required under this Agreement does not represent that coverage and limits will necessarily be adequate to protect the Applicant, nor be deemed as a limitation on Applicant's liability to AT&T in this Agreement;
- c. The parties may meet the required insurance coverages and limits with any combination of primary and Umbrella/Excess liability insurance; and
- d. The parties are responsible for any deductible or self-insured retention.
 - 4. The insurance coverage required by this Section includes:
- a. Workers' Compensation insurance with benefits afforded under the laws of any state in which the work is to be performed and Employers Liability insurance with limits of at least:

\$500,000 for Bodily Injury – each accident
\$500,000 for Bodily Injury by disease – policy limits
\$500,000 for Bodily Injury by disease – each employee
To the fullest extent allowable by Law, the policy must include a waiver of subrogation in favor of the other Party, its affiliates, and their directors, officers and employees.
In states where Workers' Compensation insurance is a monopolistic state-run system, Each Party shall add Stop Gap Employers Liability with limits not less than \$500,000 each accident or disease.

b. Commercial General Liability insurance written on Insurance Services Office (ISO) Form CG 00 01 12 04 or a substitute form providing equivalent coverage, covering liability arising from premises, operations, personal injury, products/completed operations, and liability assumed under an insured contract (including the tort liability of another assumed in a business contract) with limits of at least:

\$2,000,000 General Aggregate limit; \$1,000,000 each occurrence limit for all bodily injury or property damage incurred in any one (1) occurrence; \$1,000,000 each occurrence limit for Personal Injury and Advertising Injury; \$2,000,000 Products/Completed Operations Aggregate limit; \$1,000,000 each occurrence limit for Products/Completed Operations; \$1,000,000 Damage to Premises Rented to You (Fire Legal Liability).

The Commercial General Liability insurance policy must:

- i. include AT&T, its affiliates, and their directors, officers, and employees as Additional Insureds. Applicant shall provide a copy of the Additional Insured endorsement to AT&T. The Additional Insured endorsement may either be specific to each AT&T or may be "blanket" or "automatic" addressing any person or entity as required by contract. A copy of the Additional Insured endorsement must be provided within 60 days of execution of this Agreement and within 60 days of each Commercial General Liability policy renewal;
- ii. include a waiver of subrogation in favor of AT&T, its affiliates, and their directors, officers and employees; and
- iii. be primary and non-contributory with respect to any insurance or self-insurance that is maintained by AT&T.
- c. Business Automobile Liability insurance with limits of at least \$1,000,000 each accident for bodily injury and property damage, extending to all owned, hired, and non-owned vehicles.
- d. Umbrella/Excess Liability insurance with limits of at least \$1,000,000 each occurrence with terms and conditions at least as broad as the underlying Commercial General Liability, Business Auto Liability, and Employers Liability policies. Umbrella/Excess Liability limits will be primary and non-contributory with respect to any insurance or self-insurance that is maintained by AT&T.
- 5. With respect to AT&T's performance under this Agreement, and in addition to AT&T's obligation to indemnify, AT&T shall at its sole cost and expense, maintain the insurance coverages and/or bonds required by law and any insurance necessary to insure its activities in connection with this Agreement. AT&T shall include Applicant, its affiliates, and their directors, officers, and employees as Additional Insureds as to any insurance necessary to ensure AT&T's activities in connection with this Agreement.

J. Warranty.

- 1. Applicant Warranties.
- a. Applicant warrants for a period of two (2) years following AT&T's installation of underground communication facilities and equipment that all work and materials furnished under this Agreement:
 - i. conform in all respects to the requirements of this

Agreement;

ii. are adequate for the purposes for which they are intended;

and

- iii. to the best of AT&T's knowledge, AT&T's work and materials are free from any defects in design, materials, workmanship and title including, but not limited to, defects that will cause damage to Applicant's property, the Project site, or the District.
- b. Applicant warrants that all work it performs shall be performed by qualified personnel promptly and with diligence to AT&T's reasonable satisfaction, and that all work and materials shall be subject to all statutory and express or implied warranties.
- c. Except as disclosed to and acknowledged by AT&T in writing, Applicant is not aware of the presence of any Hazardous Substance at the locations in the District where AT&T will be installing its underground facilities.
- d. These warranties shall survive inspection, acceptance, termination and payment.
- K. <u>Title</u>. Upon the inspection and acceptance in writing of the USS by AT&T, title to the USS placed for AT&T shall vest in AT&T, provided that such is free of all liens and encumbrances.
- L. <u>Liens</u>. Applicant, its agents and contractors shall keep the USS free from any statutory or common law lien arising out of any work performed, materials furnished or obligations incurred by Applicant, its agents or contractors. In the event a lien is recorded against the USS and it is not removed from the record within thirty (30) days after written notice is given by AT&T to Applicant to do so, AT&T shall have the right to pay and discharge the lien without regard to whether the lien shall be lawful, valid or correct. Applicant shall, within thirty (30) days after written notice from AT&T, reimburse AT&T for any such claim paid by it.
- M. <u>Licenses and Easements</u>. Prior to construction of the Project, Applicant shall furnish AT&T with any and all licenses and grants of easements that are necessary for the construction, installation, and maintenance of AT&T's underground facilities.
- N. Performance. If Applicant should default in the performance of any work that it is obligated to perform under this Agreement within the time allowed for such work. AT&T may elect by submit written notice stating the alleged default. Upon receipt of written notice, Applicant and AT&T shall work together in good faith to address the default. If the default is not addressed to the satisfaction of the non-defaulting Party, either Party shall have the option of terminating this Agreement pursuant to Section IV(C) below.
- O. <u>Damage to Facilities</u>. Applicant, its employees, agents and contractors shall exercise special precaution and care to avoid causing damage to AT&T's facilities in performing work under the Project. Applicant shall assume responsibility for any and all losses, costs or expenses arising out of, or caused by such damages. Applicant shall immediately report the occurrence of any such damage to AT&T. Upon discovery of any damage, Applicant shall, on demand, reimburse AT&T for the entire expense incurred in replacing or repairing the damage.

- AT&T, its employees, agents and contractors shall exercise special precaution and care to avoid causing damage ('AT&T Damages") to Applicant's property. AT&T shall assume responsibility for any and all losses, costs or expenses arising out of or caused by such AT&T Damages. AT&T shall immediately report the occurrence of any such damage to Applicant. Upon discovery of any AT&T Damages, AT&T shall replace or repair the damage or reimburse Applicant for the associated costs.
- P. <u>Tax Liability</u>. Applicant shall pay and hold AT&T harmless from and against, all penalties, interest, taxes or other charges that are levied or assessed against Applicant.
- Q. Force Majeure.

 Neither Party shall be held liable to the other for any delay in performance under this Agreement from any cause beyond its control and without its fault or negligence, such as acts of God, acts of civil or military authority, government regulations, the presence of archeological or historical artifacts, or Hazardous Substances on, in, or near the District, embargoes, epidemics, war, terrorist acts, riots, insurrections, fires, explosions, earthquakes, nuclear accidents, floods, strikes, power blackouts, volcanic action, other major environmental disturbances, unusually severe weather conditions, inability to secure products or services of other persons or transportation facilities, or acts or omissions of carriers. If any of the foregoing events occur, both Parties agree, if requested by the other party, to accelerate its efforts hereunder if reasonably feasible in order to regain lost time, so long as requesting Party agrees to reimburse the affected Party for the incremental actual costs of such efforts.
- R. <u>Compliance with Laws</u>. Both Parties shall comply with all applicable federal, state, county, and local statutes, laws, ordinances, regulations, and codes, including the Executive Orders and regulations ("Applicable Laws") that are attached to this Agreement as Exhibit A. As used in Exhibit A, "Contractor" means Applicant. AT&T shall cooperate with Applicant to ensure compliance with all Applicable Laws, and shall immediately notify Applicant if it becomes aware of changes to Applicable Laws.

IV. GENERAL PROVISIONS.

- A. <u>Assignment</u>. Neither Party shall wholly or partially assign this Agreement without the prior written consent of the other Party, provided, however, such consent shall not be unreasonable withheld.
- B. <u>Binding Effect</u>. This Agreement shall be for the benefit of and is binding upon the respective successors and assigns of the parties.
- C. <u>Termination</u>. This Agreement automatically terminates upon completion of both Parties work required pursuant to this Agreement. In the event of any material default or breach of this Agreement, in addition to all other rights and remedies at law or in equity, the non-breaching Party may terminate this Agreement by giving thirty (30) days prior written notice of termination. The notice shall specify the cause of termination and shall give the breaching Party a reasonable opportunity to cure and correct any such cause. In the event this Agreement is terminated or suspended as provided herein, the non-breaching Party shall not be liable to the

breaching Party or any other person or entity for any losses, damages or claims which may arise as a result of termination. The breaching Party shall pay to non-breaching Party all costs and expenses incurred by non-breaching Party prior to termination of this Agreement and as a result of early termination. Any termination of this Agreement in whole or in part shall not release the Parties from any liability or obligation under this Agreement, whether of indemnity or otherwise, which may have accrued or which may be accruing or which arises out of any claim that may have accrued or may be accruing at the time of termination.

Upon early termination as the result of Applicant's breach, Applicant shall pay AT&T for all services and equipment provided prior to the notice of breach upon receipt of adequate invoices and documentation of the work. However, in no event shall AT&T's payment rise above the amounts established pursuant to Section II(F) above. Upon early termination as the result of AT&T's breach, AT&T shall provide all material and labor necessary to return the Project and Applicant's property back to its original working condition at no charge to the Applicant.

- D. <u>Entire Agreement</u>. This Agreement and the attached Exhibit, which is incorporated herein, constitute the entire Agreement between the parties with respect to the subject matter. All prior agreements, representations, statements, negotiations and understandings are superseded.
- E. <u>Independent Contractor</u>. Applicant, its agents, employees and contractors shall perform all work under this Agreement as independent contractors and not as affiliates, partners, joint ventures, agents, employees, servants or assigns of AT&T.

AT&T, its agents, employees and contractors shall perform all work under this Agreement as independent contractors and not as affiliates, partners, joint ventures, agents, employees, servants or assigns of AT&T.

- F. <u>Jurisdiction</u>. This Agreement shall be governed by the laws of the State of California and is subject to the applicable rules, regulations and tariffs on file with the CPUC and is also subject to changes or modifications as the CPUC may order.
- G. <u>Notices</u>. All notices and other communications hereunder shall be in writing, addressed as follows, and deemed given when delivered in person, delivered to an agent such as an overnight or similar delivery service, or three days after deposited in the United States mail, postage prepaid.

- H. <u>Waiver and Amendment</u>. The provisions of this Agreement shall not be waived, altered, or amended by any representations or promises of any party unless consented to in writing by both parties.
- I. Attorney's Fees. If any action is brought to adjudicate the rights granted in this Agreement or to enforce any of the terms of this Agreement, the prevailing party shall be entitled to an award of reasonable attorneys' fees in an amount to be determined by a court or a tribunal of competent jurisdiction.

If the court finds that any provision in this Agreement is invalid or unenforceable, but that by limiting such provisions would become valid and enforceable, then such provision(s) should be deemed to be written, construed and enforced as so limited.
- K. <u>Conflict of Interest.</u> AT&T hereby represents, warrants and covenants that: (i) at the time of execution of this Agreement, AT&T has no interest and shall not acquire any interest in the future, whether direct or indirect, which would conflict in any manner or degree with the performance of services under this Agreement; (ii) AT&T has no business or financial interests which are in conflict with AT&T's obligations to the Applicant under this Agreement; and (iii) AT&T shall not employ in the performance of services under this Agreement any person or entity having any such interests.

Exhibit A

Executive Orders and Associated Regulations

- 6. AFFIRMATIVE ACTION FOR HANDICAPPED PERSONS. In accordance with Executive Order 11758, dated January 15, 1974, and 41 C.F.R. § 60-741.20, the parties incorporate herein by this reference the regulations and contract clauses required by those provisions to be made a part of Government contracts and subcontracts.
- 7. UTILIZATION OF SMALL BUSINESS CONCERNS AND SMALL DISADVANTAGED BUSINESS CONCERNS.

The Contractor shall presume that socially and economically disadvantaged individuals include Black Americans, Hispanic Americans, Native Americans, Asian-AT&T Americans, Asian-Indian Americans and other minorities, or any other individual found to be disadvantaged by the Administration pursuant to section 8(a) of the Small Business Act.

(d) Contractors acting in good faith may rely on written representations by their subcontractors regarding their status as either a small business concern or a small business concern owned and controlled by socially and economically disadvantaged individuals.

Small Business and Small Disadvantaged Business Subcontracting Plan.

Contractor, unless it is a small business concern, as defined in section 3 of the Small Business Act, agrees to adopt and comply with a small business and small disadvantaged business subcontracting plan, which shall be included in and made a part of this contract. The parties incorporate herein by this reference the regulations and contract clauses required by 48 C.F.R., Ch. 1, §§ 19.704(4) and 19.708(b) to be made a part of Government contracts and subcontracts.

WOMEN-OWNED SMALL BUSINESSES.

Performance is substantially in labor surplus area if the costs incurred under the contract on account of manufacturing, production or performance of appropriate services in labor surplus areas exceed 50 percent of the contract price.

 (3) Ensure that LSA concerns have an equitable opportunity to (3) Ensure that LSA concerns have an equitable opportunity to compete for subcontracts, particularly by arranging solicitations, time for the preparation of offers, quantities, specifications, and delivery schedules so as to facilitate the participation of LSA concerns;

 (4) include the Utilization of Labor Surplus Area Concerns clause in subcontracts that offer substantial LSA subcontracting
- opportunities; and
- (5) Maintain records showing (1) the procedures adopted and (il) the Contractor's performance, to comply with this clause. BACKGROUND:

The District has installed two (2) traffic signals at Santiago Canyon College, one at the new Chapman Avenue campus entry and another signal at the new campus entry on Santiago Canyon Road.

In compliance with the City's development requirements, the cost for maintenance, operation, and periodic renovation of these traffic signals is the responsibility of the District.

ANALYSIS:

The attached Traffic Signal Maintenance Agreement represents the responsibilities of both the District and the City of Orange related to the long term maintenance and operation of the two (2) new signals.

The agreement has been reviewed, revised and approved by the District's legal counsel, Ms. Lindsay Thorson with AALRR.

The agreement provides for a one-time payment of \$80,000.00 by the District to the City of Orange for the maintenance, operation and renovation of both signals in perpetuity.

This cost is commensurate with similar fees charged by the City of Santa Ana, as indicated by their traffic engineer.

RECOMMENDATION:

It is recommended that the Board of Trustees approve the Traffic Signal Maintenance Agreement with the City of Orange as presented.

TRAFFIC SIGNAL MAINTENANCE AGREEMENT

THIS TRAFFIC SIGNAL MAINTENANCE AGREEMENT (herein referred to as the "Agreement") is entered into as of this ______ day of _____, 2012, by and between the CITY OF ORANGE, a municipal corporation (herein referred to as the "City"), and RANCHO SANTIAGO COMMUNITY COLLEGE DISTRICT, a political subdivision of the State of California (herein referred to as the "Property Owner").

WHEREAS, Property Owner owns real property in the City of Orange, County of Orange, State of California, described in legal descriptions and depicted as Exhibit A attached hereto and incorporated herein by this reference (the "Site"); and

WHEREAS, it is the desire of Property Owner to obtain a modified signalized intersection for vehicular access to the Site to and from East Chapman Avenue and a new signalized intersection to and from Santiago Canyon Road as shown in plat maps as Exhibit B (the "Maps") and incorporated herein by this reference; and

WHEREAS, the City has agreed to maintain the traffic signals at the signalized intersections for such vehicular access as shown on the Maps, subject to the conditions listed below.

NOW, THEREFORE, IT IS AGREED by and between the City and the Property Owner as follows:

1. The Parties agree:

- (A) That the Property Owner has prepared plans, specifications and estimates denoted by SP-3723 which includes Santiago Canyon College Street Improvements at Chapman and Santiago Canyon Entry Drives prepared by Luzuriaga Taylor, Inc., and the Traffic related plans prepared by Fehrs and Peers (herein referred to as the "Plans"), which Plans have been approved by the City and are on file with the City's Public Works Department.
- (B) That the Property Owner shall be responsible for the construction and installation, at its sole cost and expense, of all work and improvements, (hereinafter, the "System"), reflected on the Plans in accordance with the plan specifications and has and will continue to carry out the construction of the System on the Site in conformity with all applicable laws, including all applicable federal and state labor standards, including, but not limited to, the payment of prevailing wages.
- (C) The Property Owner acknowledges and agrees that the construction of the System constitutes a public work under applicable state law, and the Property Owner has abided by all laws and City policies applicable to public works projects, including, but not limited to, competitive bidding statutes and the payment of prevailing wage rates. The Property Owner caused all documents constituting the "bid package" for the System to contain all of those provisions required by state law for public works projects,

including, but not limited to, all applicable provisions of the California Public Contract Code, California Labor Code Sections 1776, 1777.5 and 1777.7. The Property Owner advertised for bids and opened all bids in accordance with state law and awarded the contract(s) for the System to the lowest responsible bidder(s) as required by state law.

- 2. The Property Owner hereby grants to the City an easement and right of ingress and egress over and across that portion of the Site (hereinafter referred to as the "Property") generally depicted on the maps attached hereto as Exhibit B and legally described on Exhibit A attached hereto and incorporated herein by this reference, for the purpose of maintaining, repairing and/or replacing those portions of the System as shall be installed upon the Site. Said Easement Deeds are recorded separately and attached to this Agreement for reference.
- 3. The Property Owner covenants and agrees, on behalf of itself, its successors and assigns, that before the issuance of use and occupancy permits, Property Owner will pay to City an amount of EIGHTY THOUSAND AND 00/100 (\$80,000.00). This payment shall be used only for future maintenance, energy and operation costs for the System in perpetuity, and represents a lump sum, present value of the System's operation and maintenance costs in perpetuity. This payment will relieve Property Owner from any and all future maintenance, energy or operation costs and obligations for the System.
- 4. Notwithstanding the foregoing, Property Owner covenants and agrees, on behalf of itself, its successors and assigns, that should at any time any portion of the System within the area depicted in Exhibit C, attached hereto and incorporated herein by this reference, which represents the Metropolitan Water District ("MWD") right-of-way easement, require alteration, repair, removal or relocation for purposes of maintaining any of the underlying MWD facilities therein, or if the aforementioned MWD facilities are damaged, Property Owner shall bear all reasonably necessary and verified expenses incurred by the City to alter, remove or relocate the System, or to repair damage to the System or MWD facilities caused by City in the course of their work under this Agreement, except to the extent that any work or expenses arise out of or are necessitated by the negligence or misconduct of the City. Prior to undertaking any work that may trigger this provision, City shall provide the District at least thirty (30) days written notice of such work and the estimated cost in advance. In the event of an emergency, defined as a threat to heath safety or general welfare, the City will provide notice and a cost estimate as soon as reasonably practical.
- 5. The Property Owner has prepared a signing and striping modification plan for that portion of Chapman Avenue and Santiago Canyon Road affected by the installation and construction of the System, which signing and striping plans reflect the signalized entries and island modifications, and an on-site signing and striping plans for the project driveways and throats (collectively, the "Signing and Striping Plans"). The Signing and Striping Plans have been approved by the City Traffic Engineer and are on file with the City's Public Works Department. The cost of all signing and striping removal, installation and modification in accordance with the current City-approved Signing and Striping Plans shall be borne by the Property Owner. The District shall not be responsible for any additional or future costs related to signing and striping, except that any change to signing and striping specifically requested by the Property Owner, which the City then approves and performs, shall be at Property Owner's expense.

- 6. Upon its completion in compliance with the Plans to the satisfaction of the City Engineer, the System shall be dedicated to and become the property of the City. The City agrees to maintain and operate the System in perpetuity, subject to the terms and conditions of this Agreement.
- 7. The City shall indemnify, defend and hold Property Owner harmless from any and all liability for damage to property or injury to person arising from the City's acts or omissions on the Site, maintenance and repair of the System after its dedication to the City or from City's access to the Site. Property Owner shall indemnify, defend, and hold City harmless from any and all liability arising from District's ownership, operation, condition or maintenance of the Site, except to the extent such liability is caused by the City's acts or omissions.
- 8. Each and all of the covenants, conditions, restrictions, obligations and provisions contained in this Agreement (whether affirmative or negative in nature) shall be covenants running with the land pursuant to California Civil Code Section 1468 in that said covenants and restrictions (i) affect the Site and the Property and each and every part thereof, (ii) benefit adjacent public lands and each and every part thereof, (iii) shall bind each and every person having any interest in the Site or the-Property or any part thereof derived through the Property Owner, whether such interest is fee, easement, leasehold, beneficial or otherwise and each successor and assign of such person, for the benefit of the Site and the Property and the public lands and every part thereof, and (iv) relate to the use, repair, maintenance and improvement of the Site and the public land and every part thereof Said terms, covenants, conditions, restrictions and easements shall also be mutual equitable servitudes upon the Site and the Property and each part thereof in favor of and appurtenant to each and every other part thereof and the public lands, and shall bind each and every person having any interest in the Site or the Property or any part thereof, whether such interest is fee, leasehold, beneficial or otherwise, and each successor or assign of such person having any such interest in the Site or the Property or any part thereof.
- 9. In any lawsuit or other legal action taken to enforce any provision of this Agreement on the collection of any amount due hereunder, the prevailing party shall be entitled to recover its reasonable attorneys' fees.
- 10. Invalidation of any of the covenants, conditions, restrictions, or other provisions contained herein by judgment or court order shall in no way affect any of the other covenants, conditions, restrictions, or provisions hereof, and the same shall remain in full force and effect.
- 11. Except as otherwise expressly provided in this Agreement, in every case when, under the provisions of this Agreement, it shall be necessary or desirable for one party to serve any notice, request, demand, report or other communication on the other party, the same shall be in writing and shall not be effective for any purpose unless served (a) personally, (b) by independent, reputable, overnight commercial courier, (c) by facsimile transmission (1) where the transmitting party includes a cover sheet identifying the name, location and identity of the transmitting party, the phone number of the transmitting device, the date and time of the transmitting device or receiving device records verification of receipt and the date of receipt and the date and time of transmission receipt and the phone number of the other device, and (3) where the facsimile transmission is immediately followed by service of the original of the subject

item in the manner provided in subsection (a), (b) or (d) hereof, or (d) by deposit in the United States mail, postage and fees fully prepaid, registered or certified mail, with return receipt requested, addressed as follows:

Any amendment permitted hereunder shall be by written instrument duly executed under notary by the persons described above and recorded in the Office of the Orange County Recorder.
- 15. The Parties may execute this document in two or more counterparts which shall, in the aggregate, be executed by all the Parties; each counterpart shall be deemed an original instrument as against any party who has executed it.

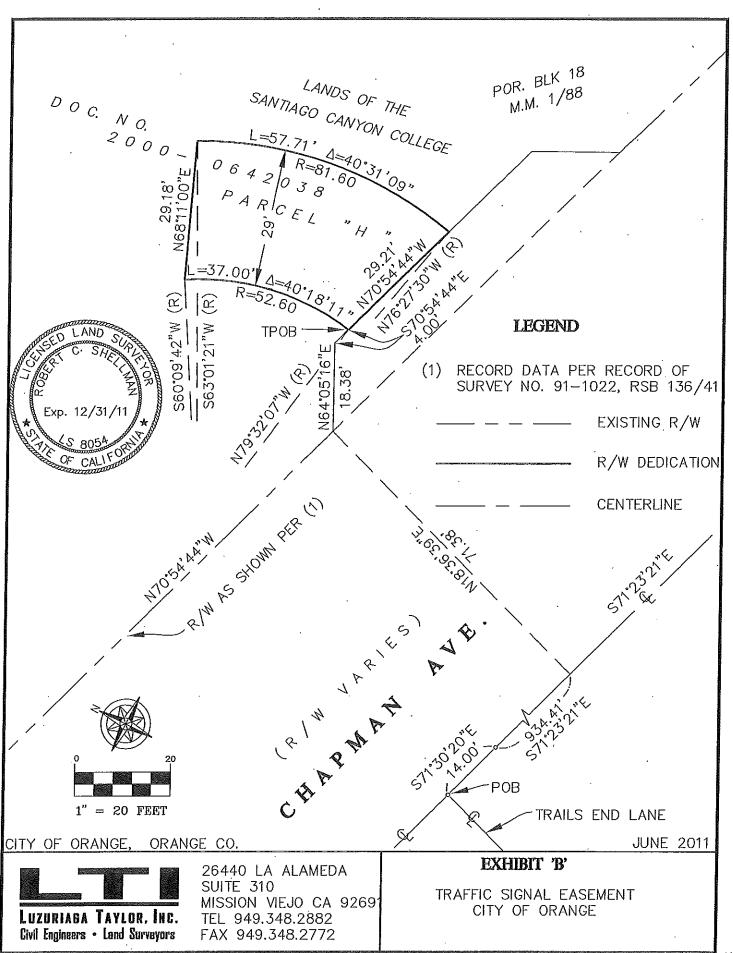

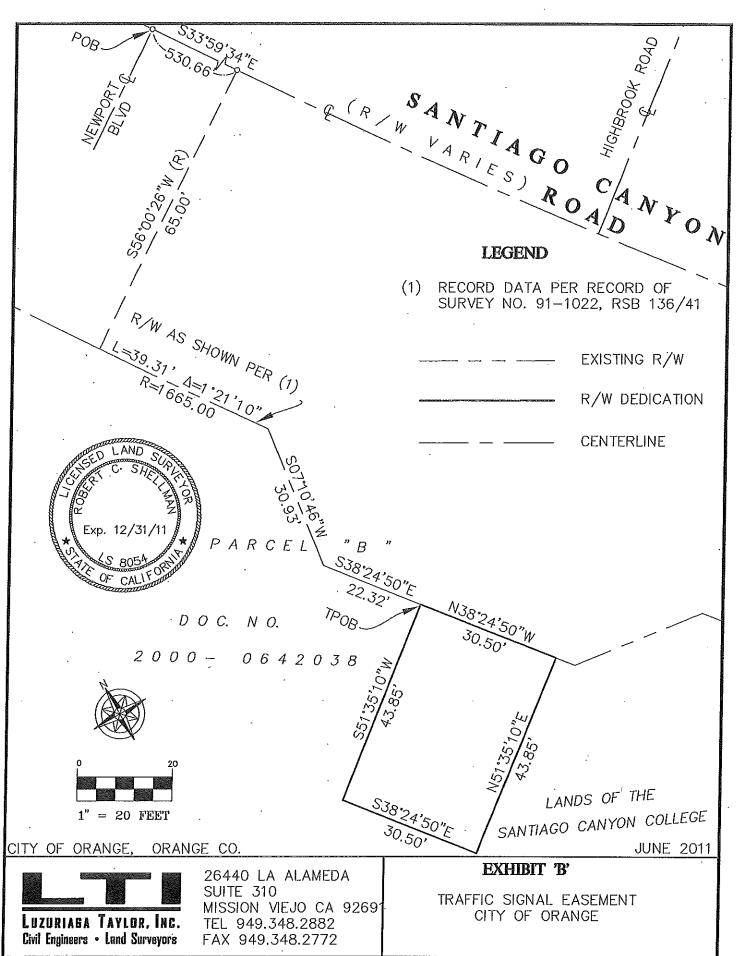

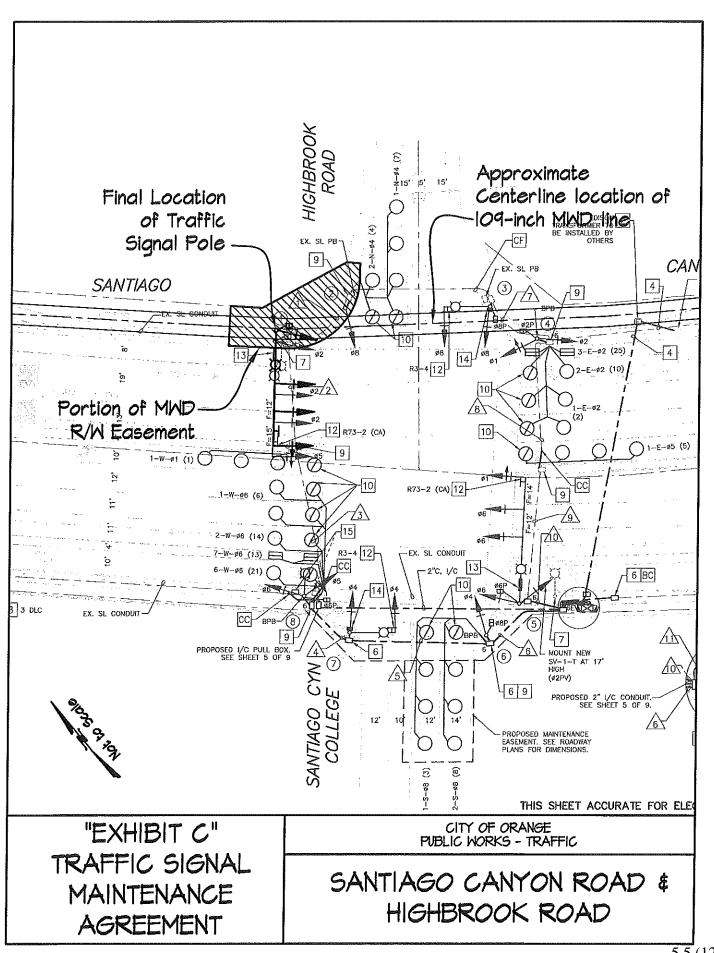

BACKGROUND;

On January 17, 2012 the Board of Trustees awarded Bid #1183 District –Wide Surveillance System, Installation and Integration. District staff requested that to meet future needs and provide network support that fiber infrastructure should be included in the project.

In compliance with Public Contract Code, Bid #1199 Fiber Infrastructure at Santiago Canyon College was appropriately advertised and plans/specifications made available to prospective bidders.

ANALYSIS:

The current fiber infrastructure at Santiago Canyon College is antiquated and can no longer effectively support the new technology that is being utilized District-wide, such as video surveillance. By investing and updating the Santiago Canyon College fiber infrastructure, it will ensure viability and compatibility with the current and future District technology, as well as provide faster, more robust, and reliable connection to the network throughout campus.

Bids were opened on August 22, 2012 for Fiber Infrastructure at Santiago Canyon College as noted on the attached Bid Results Form. The lowest cost responsible bidder was Steele Contracting, Inc. dba Coast Electric for the amount of \$294,368.00

District staff has provided a "due diligence" review of the lowest responsible bidder, Steele Contracting, Inc. dba Coast Electric and verification has been made for the appropriate license, compliance with necessary bond requirements, and has no record of labor complaints.

RECOMMENDATION:

It is recommended that the Board of Trustees award Bid #1199 for the Infrastructure at Santiago Canyon College to Steele Contracting, Inc. dba Coast Electric as presented.

BACKGROUND

A partial award of Bid #1190 – Athletic and Aquatic Equipment and Supplies for the Athletic/Aquatic Complex at Santiago Canyon College (SCC) was approved at the September 10, 2012 Board meeting. We are asking approval and award to the lowest responsive and responsible bidders meeting specifications for the remaining items.

ANALYSIS

The remaining items in the chart below have been evaluated by the SCC campus committee. Item 9 is being removed because the committee felt that a twin-tier dumbbell rack was not sufficient and space requirements require a triple-tier. Items 15, 17, 22, 28-30 and 33 are being awarded to the lowest responsive and responsible bidders; items 21, 27, 31 and 32 are being awarded to the second lowest responsive and responsible bidders; and items 23-26 are being awarded to the third lowest responsive and responsible bidders. (Items 21-32 are being awarded to the second and third lowest responsive and responsible bidders because the low bidders' items offered either less than or greater than 20% of the requested weight stacks.) Item 19 is being awarded to the highest bidder because this product is more accessible to visually and physically impaired users.

TERMINATION AGREEMENT AND MUTUAL RELEASE

This Termination Agreement and Mutual Release (the "Termination Agreement") is effective as of the first day of December, 2012, by and between ACT, Inc., a nonprofit corporation organized and existing under the laws of the State of Iowa ("ACT"), and Rancho Santiago Community College Distr, ("Participant"), each of ACT and Participant being a "Party" and, collectively, the "Parties".

RECITALS

WHEREAS, the Parties wish to terminate the Participation Agreement on the terms and conditions contained in this Termination Agreement.

AGREEMENT

Now, therefore, expressly incorporating the foregoing recitals as part of the consideration hereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

- 1. DEFINITIONS. Unless otherwise set forth herein, the capitalized terms in this Termination Agreement shall have that meaning given to them in the Participation Agreement.
- 2. TERMINATION OF PARTICIPATION AGREEMENT. Subject to the terms and conditions of this Termination Agreement, the Parties agree that the Participation Agreement is hereby terminated and shall have no further force and effect; provided, however, that the terms of the Participation Agreement relating to Confidential Information, return of equipment, limitation of liability and the nature of the Parties' relationship shall survive such termination.
- 3. EQUIPMENT AND ACT CONFIDENTIAL INFORMATION. ACT will be responsible for removing any personally identifiable information or confidential information from all servers and proctor workstations within 60 days of termination. After the servers and proctor workstations have been wiped clean in this manner, Participants are free to utilize or dispose of the equipment. Participant agrees that the equipment is provided "as is", and without any warranties of any kind, express or implied, including but not limited to the implied warranties of merchantability or fitness for a particular purpose. Participant further agrees that ACT will no longer be responsible for the equipment in any way, including but not limited to the maintenance, repair, or licensing of related equipment or software. Participant further agrees that within 10 day s of termination, Participant shall destroy all confidential information and ACT Center proprietary manuals including the Operations Manual, Protocols, and ACT Center Signs. ACT requests that completed EASI forms be retained for the standard 30 days.

4. MUTUAL RELEASES

(a) Participant for itself, and its successors, assigns, trustees, officers, directors, partners, employees, representatives, and agents, does hereby release and forever discharge ACT, its successors, assigns, trustees, officers, directors, partners, employees, representatives, and

agents, both individually and in their representative corporate capacity, from all claims, demands, actions, damages, costs, expenses, covenants, contracts, agreements, and compensation whatsoever, whether now known or unknown, foreseen or unforeseen, patent or latent, which it can claim or assert against ACT, or its successors, assigns, trustees, officers, directors, partners, employees, representatives, or agents that arose from the Participation Agreement prior to the date of this Termination Agreement.

(b) ACT for itself, and its successors, assigns, trustees, officers, directors, partners, employees, representatives, and agents, does hereby release and forever discharge Participant, its successors, assigns, trustees, officers, directors, partners, employees, representatives, and agents, both individually and in their representative corporate capacity, from all claims, demands, actions, damages, costs, expenses, covenants, contracts, agreements, and compensation whatsoever, whether now known or unknown, foreseen or unforeseen, patent or latent, which it can claim or assert against Participant, or its successors, assigns, trustees, officers, directors, partners, employees, representatives, or agents that arose from the Participation Agreement prior to the date of this Termination Agreement.

5. REPRESENTATIONS AND WARRANTIES; FURTHER ASSURANCES; CONFIDENTIALITY; CERTAIN COVENANTS

- (a) Each of ACT and Participant hereby represents and warrants: (i) that the execution, delivery, and performance of this Termination Agreement has been duly authorized and approved by all necessary action on its part; (ii) that, upon execution and delivery of this Termination Agreement, this Termination Agreement will constitute the valid and binding obligation of such Party, enforceable against it in accordance with its terms; (iii) that it has not assigned or transferred, in whole or in part any claim such Party now has or may have against the other, or any portion thereof or interest therein to any person or entity and that all right, title, and interest to such claims is held by the releasing Party.
- (b) Each of the Parties hereto agrees to take any and all further actions necessary on its part to carry out the terms of this Termination Agreement.
- 6. BINDING EFFECT. The provisions of this Termination Agreement shall inure to the benefit of, and be binding upon, the Parties hereto and their respective successors and assigns.

Thank you for the opportunity to be of service. The purpose of this letter is to confirm the terms upon which AlvaradoSmith ("Firm" or "we") will provide legal service Rancho Santiago Community College District ("you" or "your"). This letter shall expire by its own terms if not signed, dated and received by the Firm within fifteen (15) calendar days from the date of this letter.

- 1. **Scope of Representation**. The Firm will provide legal services to you in connection with the acquisition or lease of various real property rights ("Services").
- 2. **The Retainer**. The Firm's policy requires that we obtain a retainer from you prior to commencing any Services. However the firm has agreed to waive the retainer requirement.
- 3. **Fees and Billing Policy**. I, as a shareholder of the Firm, will be primarily responsible for your representation. I will be assisted by my partners Craig D. Hardwick, John G. Cruz and our associate Erica Diaz. From time to time, other Firm attorneys or paralegals may work on your matters when appropriate and cost-effective.

Our legal fees are based on how much time is spent on your matter and by whom it is spent. Time is charged in minimum units of tenths (1/10) hours. The standard hourly rate for me is \$520, the standard hourly rate for Craig D. Hardwick and John G. Cruz is \$500. Erica M. Diaz's standard rate is \$290, respectively. Our current rates for other attorneys range from \$240



to \$580. However, as a courtesy, for matters that we handle for you, so long as you make invoiced payments of all amounts due this Firm within thirty (30) days from the date of the invoice, we will charge you our discounted rates which range between \$220 and \$495. My discounted hourly rate is \$325. The discounted rate for Craig D. Hardwick and John G. Cruz is \$325. Erica M. Diaz's discounted hourly rate is \$275. Please note that we are giving you the discounted rates as a courtesy only if invoices are paid within thirty (30) days from the invoice date. Should you fail to keep current on any outstanding invoices you owe to the Firm, the Firm reserves the right to withdraw the discount and invoice you at the Firm's then current standard hourly rates. Further, all additional work, if any, will be completed at the Firm's then current standard hourly rates. Subject to applicable laws, the Firm will withdraw as your counsel if you fail to timely pay your invoices. From time to time the Firm reviews and may increase hourly rates. We will give you advance notice should hourly rates be increased.

Invoices for out-of-pocket expenses, parking and other local travel expenses, computerized legal services, outsourced photocopying and other reproduction costs, clerical staff overtime, long-distance telephone charges, deposition transcripts, expert witness fees, courier and messenger services, and postage, will be billed monthly at the actual cost incurred by us. If required in the course of representing you, you also agree to pay transportation, meals, lodging and all other costs of any necessary out-of-town travel by our personnel. In-office photocopying is billed at 25¢ per page, facsimiles at \$1.00 per page, and personal automobile mileage at 51¢ per mile. Firm policy prevents us from advancing money on behalf of clients for out-of-pocket costs attendant to the Services. You must pay for any out-of-pocket costs required in connection with your matter directly as such costs are incurred.

The Firm will bill you for its services and expenses monthly. You agree to pay the Firm's statements upon presentation. Each statement is delinquent if not paid within thirty (30) days from its date. Any amount not paid within sixty (60) days of the invoice date shall accrue interest at the rate of ten percent (10%) per year. If any statement is not paid promptly, we reserve the right to discontinue performing services. If you have questions concerning your statement at any time, please do not hesitate to contact me for clarification.

If you are ordered to pay costs or attorney fees incurred by another party, you will be responsible for that payment. Conversely, if any such fees or costs are paid to the Firm, we will credit such amount against what you owe the Firm. In the event a recovery is obtained or transaction is completed, you hereby grant the Firm a lien on the proceeds obtained in the amount of all unpaid attorney fees and costs advanced on all Services or other matters handled by the Firm on your behalf.

4. **Conflicts of Interest**. Based on our discussions with you, we have not identified any conflicts of interest which we believe would legally prevent us from performing the Services. In the event any potential conflict is subsequently identified, we will immediately notify the

Failure to provide such information could prejudice your interests in such litigation and transactional matters and may ultimately reduce the effectiveness of our representation.
- 6. **Responsibility for Fees**. If more than one individual or entity retains the Firm pursuant to this agreement, each individual or entity is jointly and severally responsible for all fees and costs accruing hereunder, regardless of whether the Firm bills or accepts payment in accordance with an apportionment agreement entered into by the client(s).
- 7. **Insurance Coverage Issues**. At your instruction, we will cooperate with your insurance carrier and insurance professionals by providing information regarding your claim and copies of your billings. Unless otherwise specifically agreed to by the Firm in writing, insurance coverage and payment issues are expressly your responsibility. - 9. **Termination**. The law gives you the right to terminate the Firm at any time. Similarly, subject to the Firm giving you reasonable notice for you to arrange alternative counsel, we have the right to discontinue work on pending matters or terminate our attorney-client relationship at any time (i) that a statement remains due and unpaid sixty (60) days after it has been sent, (ii) when we believe that our relationship with you violates ethical principles and standards, or (iii) termination of the relationship is required or permitted by law.

All files and/or documents retained at the Firm relating to your representation are now and will remain your property ("Client Files") except for the Firm's internal and/or administrative documents, such as attorney work sheets and time sheets. You may have access to your Client Files upon reasonable advance notice, and upon termination of our representation, you may withdraw your Client Files with prior written notice. The Firm reserves the right to

- Santa Ana College/Orange County Sheriff's Regional Training Academy
- Santa Ana College Digital Media Center
- Santiago Canyon College
- Santiago Canyon College Orange Education Center

This section will consist largely of policies in the current RSCCD 9000 Section, "By-laws of the Board" and a few in the 2000 Section, "Administration." The following policies are presented in the order listed in the CCLC model.

BP 2010 Board Membership - BP9003

References:

Education Code Sections 5000 et seq., 72023, 72103, 72104

The Board of Trustees of the Rancho Santiago Community College District shall consist of seven members elected by the qualified voters of the District who shall each serve four-year terms. Members shall be elected by trustee area as defined in Board Policy 2100. Trustees will reside in certain specified trustee areas, but be elected at large by the voters. Three trustees shall represent Area 1, one trustee Area 2, and three trustees Area 3 (see Board Policy 9004 for a description of trustee area boundaries).

It is the intent of the Board that beginning with the November 2012 election, each trustee will reside in one of seven specified trustee areas, and be elected by the voters residing in that area.

The Board of Trustees may change the methodology utilized for electing Board members in any manner consistent with law.

Any person who meets the criteria contained in law is eligible to be elected or appointed a member of the Board.

An employee of the district may not be sworn into office as an elected or appointed member of the governing board unless he or she resigns as an employee.

No member of the governing board shall, during the term for which he or she is elected, hold an incompatible office.

Revised: February 6, 2012 (Previously BP9003)

BP 2015 Student Trustee Member - BP9006

Legal Reference:

Education Code Sections 72023.5 and 72425

The Board shall include one non-voting student member. The term of office shall be one year commencing June 1.

The student member shall be a resident of California at the time of nomination, and during the term of service, and shall be enrolled in and maintain a minimum of five (5) semester units in the District at the time of nomination and throughout the term of service. The student member is not required to give up employment with the District. The student shall maintain the standards of scholarship and eligibility criteria enumerated in Administrative Regulation 9006.

The student member shall be seated with the Board and shall be recognized as a full member of the Board at meetings. The student member is entitled to participate in discussion of issues and receive all materials presented to members of the Board (except for closed session). The student member shall be entitled to any

mileage allowance necessary to attend board meetings <u>and reimbursement for travel (see BP 2735)</u> to the same extent as publicly elected trustees.

The student member shall have the privilege to cast an advisory vote, although the vote shall not be included in determining the vote required to carry any measure before the board. The student member may, prior to the vote on any item before the Board, advise the President of the Board that the student member would like to cast his/her vote first as a means of providing advice to the Board.

The student member shall not be liable for any acts of the Governing Board.

On or before May 15 of each year, the Board shall consider whether to afford the student member any of the following privileges:

- The privilege to make and second motions;
- The privilege to attend closed sessions, other than closed sessions on personnel or collective bargaining matters;
- The privilege to receive compensation for meeting attendance and the amount of that compensation, up to the amount prescribed by Education Code Section 72425.
- The privilege to serve a term commencing on May 15.
- The privilege to serve on Board committees.

TRUSTEE AREA ONE - THREE BOARD MEMBERS

Essentially this area includes the largest and western portion of Santa Ana, extending westerly to Euclid Street in Fountain Valley, and generally bounded by Westminster Avenue/17th Street to the north, Halladay to the east, and Sunflower Avenue on the South.

TRUSTEE AREA TWO - ONE BOARD MEMBER

Essentially this area includes the eastern portion of Santa Ana, and takes in small northerly sections of Irvine, Costa Mesa and Newport Beach in the John Wayne Airport area, extending past Jamboree Road to the southeast and south to the San Joaquin (73) Freeway, and is generally bounded to the north by LaVeta Avenue in Orange, Halladay Street and Rousselle Street to the west (north of Warner Avenue), south Bristol Street to the west (south of Warner Avenue), and Lyon Street to the east.

TRUSTEE AREA THREE - THREE BOARD MEMBERS

Essentially this area includes the northern portion of the Rancho-Santiago Community College District, Orange, Villa Park, and Anaheim Hills, extending southerly to LaVeta Avenue in Orange and Westminster Avenue in Garden Grove, and westerly to Euclid Street. The eastern area extends along Santiago Canyon Road southerly to the Modjeska Canyon area, easterly to the county line, and to the Santa Ana River which forms the northern district boundary. (Click here to view map)

It is the intent of the Board that the current configuration of three trustee areas will be replaced by a seven trustee area configuration prior to the November 2012 election.

The term of office of each trustee shall be four years, commencing on the first board meeting in December following the general election in November. Elections shall be held every two years, in even numbered years. Terms of trustees are staggered so that, as nearly as practical, one half of the trustees shall be elected at each trustee election.

The Board of Trustees has provided for the election of trustees by trustee areas. Effective May 21, 2012, the trustee areas are:

Area 1: Area One includes a central strip of Santa Ana, generally bounded by 17th Street and 1st Street in the north, Main St to the east, and Flower, Bristol and Raitt Streets to the west, down to the District border.

Area 2: Essentially Area Two includes Santa Ana east of Main Street up to 17th Street. Area Two also includes small northerly sections of Irvine, Costa Mesa and Newport Beach in the John Wayne Airport area, extending past Jamboree Road to the southeast and south to the San Joaquin (73) Freeway, and is generally bounded to the north by LaVeta Avenue and Highway 22, east to Prospect Avenue and west to Santiago Street.

Area 3: Essentially Area Three includes the central and southwestern portions of Santa Ana, bordered by Fairview and the River on the west, Bristol, Flower and Raitt on the east, the District border to the south, and 17th Street and Civic Center Drive on the north.

Area 4: Area Four includes the City of Garden Grove territory north of Garden Grove Blvd or east of Harbor Boulevard, together with the City of Orange territory generally west of Batavia, Glassell and Highway 55, south of Walnut, Katella, and Taft respectively.

Area 5: Area Five consists of the portion of Garden Grove south of Garden Grove Boulevard and west of Harbor Boulevard, Santa Ana west of the River, and northern Santa Ana bordered by the City border on the north, Santiago St on the east, and 17th Street on the south, plus the portion of Santa Ana bordered by 17th Street on the north, Flower Street on the east, Civic Center Drive on the south, and Bristol Street on the west.

Area 6: Area six consists of Anaheim Hills, the eastern hills portion of the District, Villa Park, and Orange generally east of Villa Park and Cannon Street.

Area 7: Area Seven is entirely within the City of Orange, covering territory west and south of Villa Park, bordered by Highway 55, the City of Villa Park, and Cannon Street in the east, the District borders to the north and south, and by Batavia, Glassell and Highway 55 to the west.

The election of a board member residing in and registered to vote in the trustee area he or she seeks to represent shall be only by the registered voters of the same trustee areas.

The Board Policy Committee shall meet following each decennial federal census and, in conjunction with the Chancellor, shall recommend to the Board any adjustments to each trustee area. There will not be an adjustment of trustee area boundaries between decennial censuses unless the district acquires or loses territory.

BP 2110 Vacancies on the Board - BP9005

Legal References:

Education Code Sections 5090, et seq., Government Code 1770

Vacancies on the Board may be caused by any of the events specified in Government Code Section 1770 or any applicable provision in the Elections Code, or by a failure to elect. Resignations from the Board shall be governed by EC 5090.

Within 60 days of the vacancy or filing of a deferred resignation, the Board shall either order an election or make a provisional appointment to fill the vacancy.

If an election is ordered, it shall be held on the next regular election date not less than 130 days after the occurrence of the vacancy.

If a provisional appointment is made, it shall be subject to the conditions in EC 5091. The person appointed to the position shall hold office only until the next regularly scheduled election for district governing board members, when the election shall be held to fill the vacancy for the remainder of the unexpired term.

The provisional appointment will be made by a majority public vote of the board members at a public meeting.

The Chancellor shall establish administrative procedures to solicit applications that assure ample publicity to and information for prospective candidates. The Board will determine the schedule and appointment process.

The Board of Trustees has full legal authority and responsibility for the Rancho Santiago Community College District. It derives its powers from the Constitution of the State of California and the acts of the Legislature.

The basic duties of the Board include the selection of the chief executive officer, the declaration of principal objectives, the development of policies, the preservation of assets, the expenditure of funds, the establishment of policies for development of current and long-range planning, and the determination of a governance structure.

The Board shall exercise such additional powers, functions, and responsibilities as provided by law-

The Board of Trustees governs on behalf of the citizens of the District in accordance with the authority granted and duties defined in Education Code Section 70902.

The Board is committed to fulfilling its responsibilities to:

Officers of the Board shall be elected at the annual organizational meeting and shall include a President, Vice President, and Clerk. They shall serve a term of one year. The Chancellor of the District shall serve as secretary to the Board.

At the board meeting immediately prior to the annual organizational meeting, the Board President shall solicit expressions of interest from members of the Board, or any newly elected members of the Board, regarding service as President, Vice President or Clerk of the Board, as well as any committee assignments.

At the annual organizational meeting, the Board shall elect from among its members a President of the Board, Vice President, Clerk.

- A. **President**: It shall be the duty of the president to:
 - Preside over all meetings of the Board;
 - Represent the district at all official functions;
 - Serve as the official spokesperson for the Board;
 - · Call emergency and special meetings of the Board as required by law;
 - Consult with the Chancellor on board meeting agendas;
 - Communicate with individual Board members about their responsibilities:
 - Participate in the orientation process for new Board members;
 - Assure Board compliance with policies on board education, self-evaluation and the Chancellor's evaluation;
 - Represent the Board at official events or ensure board representation.
- B. **Vice-President**: It shall be the duty of the vice president to serve in the absence of the president of the Board. The vice president shall perform such other duties as required by the president or by actions of the Board.
- C. **Clerk**: It shall be the duty of the clerk to certify or attest to official actions taken by the Board and to monitor the making and maintenance of records as required by law.
- D. Secretary: The Chancellor shall serve as Secretary to the Board. It shall be the duty of the secretary to:
 - Prepare the agenda for each meeting, in consultation with the Board President;
 - Assure the official posting of the call of each meeting in compliance with law;
 - Notify members of the Board of regular, special, emergency and adjourned meetings;
 - Supervise the preparation of minutes of meetings for Board consideration and approval;

- Provide back-up data on all items to be under consideration;
- · Attend all Board meetings and closed sessions, unless excused, and in such cases to assign a designee;
- Conduct the official correspondence of the Board;
- · Certify as legally required all board actions;
- Sign, when authorized by law or by Board action, any documents that would otherwise require the signature of the Secretary or the Clerk of the Board.
- The terms of officers shall be for one year. The Board does not have an official system of rotation of officers; it elects the officers each year from among all its members.

Annually, the president of the Board shall appoint members to the Standing committees. Standing and ad hoc committees may be limited and/or created as deemed necessary by a majority of the Board. The Executive Committee of the Board is comprised of the President, Vice President, and Clerk of the Board. The Chancellor serves as staff to all Board of Trustee committees.

Any committee established by Board of Trustees action shall comply with the requirements of the Brown Act and with policies regarding open meetings.

The Board's time and place of meetings shall be determined at the district's annual organizational meeting and may be changed by the Board President in consultation with the Chancellor. Regular meetings of the Board shall normally be held in Room 107 of the District Office, located at 2323 N. Broadway, Santa Ana, California.

A notice identifying the location, date, and time of each regular meeting of the Board shall be posted at least ten (10) days prior to the meeting and shall remain posted until the day and time of the meeting. All regular meetings of the Board shall be held within the boundaries of the District except in cases where the Board is meeting with another local agency or is meeting with its attorney to discuss pending litigation if the attorney's office is outside the District.

Authority to Conduct Business

No business shall be conducted by the Board except at a regular meeting or adjourned thereof, or at a duly called special meeting.

All regular and special meetings of the Board shall be open to the public, be accessible to persons with disabilities, and otherwise comply with Brown Act provisions, except as required or permitted by law.

Consent Calendar

In consultation with the Chancellor, the president shall designate routine items of business for a "Consent Calendar." Any item may be removed from the consent calendar upon request of any member of the Board.

Closed sessions of the Board shall only be held as permitted by applicable legal provisions including but not limited to the Brown Act, California Government Code and California Education Code. Matters discussed in closed session may include:

 the appointment, employment, evaluation of performance, discipline or dismissal of a public employee;

- charges or complaints brought against a public employee by another person or employee, unless the accused public employee requests that the complaints or charges be heard in an open session. The employee shall be given at least twenty-four (24) hours written notice of the closed session.
- advice of counsel on pending litigation, as defined by law;
- consideration of tort liability claims as part of the district's membership in any joint powers agency formed for purposes of insurance pooling;
- real property transactions;
- threats to public security;
- review of the District's position regarding labor negotiations and giving instructions to the District's designated negotiator;
- discussion of student disciplinary action, with final action taken in public;
- conferring of honorary degrees;
- consideration of gifts from a donor who wishes to remain anonymous;
- to consider its response to a confidential final draft audit report from the Bureau of State Audits.

The agenda for each regular or special meeting shall contain information regarding whether a closed session will be held and shall identify the topics to be discussed in any closed session in the manner required by law.

After any closed session, the Board shall reconvene in open session before adjourning and shall announce any actions taken in closed session and the vote of every member present.

All matters discussed or disclosed during a lawfully held closed session and all notes, minutes, records or recordings made of such a closed session are confidential and shall remain confidential unless and until required to be disclosed by action of the Board or by law.

BP 2320 Special and Emergency Meetings - Special-BP9020

Special meetings may be called by the President of the Board or by a majority of the members of the Board. Notice of such meetings shall be posted at least 24 hours before the time of the meeting, and shall be noticed in accordance with the Brown Act. No business other than that included in the notice may be transacted or discussed.

Emergency meeting may be called by the President of the Board when prompt action is needed because of actual or threatened disruption of public facilities under such circumstances as are permitted by the Brown Act, including work stoppage, crippling disasters, and other activity that severely impairs public health or safety.

No closed session shall be conducted during an emergency meeting, except as provided for in the Brown Act to discuss a dire emergency.

The Chancellor shall be responsible to ensure that notice of such meetings is provided to the local news media as required by law.

BP 2330 Quorum and Voting - BP9016

A majority of the members of the Board shall constitute a quorum for the transaction of business. Four votes shall be necessary to determine the outcome of any issue. Less than a quorum may adjourn any meeting to a future date.

Two members of the Board shall constitute a quorum for any meeting of a standing or ad hoc committee of the Board.

The Board shall act by majority vote of all the membership of the Board, except as noted below.

No action shall be taken by secret ballot.

The following actions require a two-thirds majority of all members of the Board:

- Resolution to pursue the authorization and issuance of bonds by a 55% vote of the electorate;
- Resolution of intention to sell or lease real property (except where an unanimous vote is required);
- Resolution of intention to dedicate or convey an easement;
- Resolution authorizing and directing the execution and delivery of a deed;
- Action to declare the District exempt from approval requirements of a planning commission or other local land use body;
- Appropriation of funds for an undistributed reserve;
- Resolution to condemn real property.

The following actions require a unanimous vote of all the members of the Board:

- Resolution authorizing a sale or lease of District real property to the state, any county, city or to any
 other school or community college district;
- Resolution authorizing lease of District property under a lease for the production of gas.

BP 2340 Agendas - BP9015

Legal References:

Government Code Sections 54954 et seq., 6250 et seq.; Education Code Sections 72121, 72121.5

An agenda shall be posted adjacent to the place of meeting at least 72 hours prior to the meeting time for regular meetings. The agenda shall include a brief description of each item of business to be transacted or discussed at the meeting. If requested, the agenda shall be provided in appropriate alternative formats so as to be accessible to persons with a disability.

No business may be acted on or discussed which is not on the agenda, except when one or more of the following apply:

a majority decides there is an "emergency situation" as defined for emergency meetings;

- two-thirds of the members (or all members if less than two-thirds are present) determine there is a
 need for immediate action and the need to take action came to the attention of the Board
 subsequent to the agenda being posted;
- an item appeared on the agenda of and was continued from a meeting held not more than five days earlier.

The order of business may be changed by consent of the Board.

The Chancellor shall establish administrative procedures that provide for public access to agenda information and reasonable annual fees for the service.

Members of the public may place matters directly related to the business of the District on an agenda for a board meeting by submitting a written summary of the item to the Chancellor. The written summary must be signed by the initiator. The Board reserves the right to consider and take action in closed session on items submitted by members of the public as permitted or required by law.

Agendas shall be developed by the Chancellor in consultation with the Board President.

Individual Board members who wish to place matters on the agenda shall consult with the Board President, who shall confer with the Chancellor on the request.

Agenda items submitted by members of the public must be received by the office of the Chancellor 10 working days prior to the regularly scheduled board meeting.

Agenda items initiated by members of the public shall be placed on the Board's agenda following the items of business initiated by the Board and by staff. Any agenda item submitted by a member of the public and heard at a public meeting cannot be resubmitted before the expiration of a 90 day period following the initial submission. See Administrative Regulation 9015.

BP 2345 Public Participation at Board Meetings - BP9014

Legal-References:

Government Code Sections 54954.3, 54957.5; Education Code 72121.5

The Board shall provide opportunities for members of the general public to participate in the business of the Board.

Members of the public may bring matters directly related to the business of the District to the attention of the Board in one of two ways:

- There will be a time at each regularly scheduled board meeting for the general public to discuss items not on the agenda. Members wishing to present such items shall submit a written request at the beginning of the meeting to the Chancellor that summarizes the item and provides his or her name, address or college of attendance, and organizational affiliation, if any. No action may be taken by the Board on such items.
- Members of the public may place items on the prepared agenda in accordance with Board Policy 9015. A written summary of the item must be submitted to the Chancellor at least 10 working days prior to the board meeting. The summary must be signed by the initiator, contain his or her residence or business address, and organizational affiliation, if any.

Members of the public also may submit written communications to the Board on items on the agenda and/or speak to agenda items at the board meeting. Written communication regarding items on the Board's agenda should reach the office of the Chancellor not later than 1 working day prior to the meeting at which the matter concerned is to be before the Board. All such written communications shall be dated and signed by the author, and shall contain the residence or business address of the author and the author's organizational affiliation, if any.

If requested, writings that are public records shall be made available in appropriate alternative formats so as to be accessible to persons with a disability.

Claims for damages are not considered communications to the Board under this rule, but shall be submitted to the District.

BP 2350 Speakers - BP9014.1

Legal References:

Government Code Sections 54950, et seq.; Education Code Section 72121.5

Persons may speak to the Board either on an agenda item or on other matters of interest to the public that are within the subject matter jurisdiction of the Board.

Oral presentations relating to a matter on the agenda, including those on the consent agenda, shall be heard before a vote is called on the item.

Persons wishing to speak to matters not on the agenda shall do so at the time designated at the meeting for public comment.

Those wishing to speak to the Board are subject to the following:

- The President of the Board may rule members of the public out of order if their remarks do not pertain to matters that are within the subject matter jurisdiction of the Board or if their remarks are unduly repetitive.
- Non-scheduled substitutes may not speak in place of scheduled speakers unless alternates have been submitted on the original request.
- Employees who are members of a bargaining unit represented by an exclusive bargaining agent may address the Board under this policy, but may not attempt to negotiate terms and conditions of their employment. This policy does not prohibit any employee from addressing a collective bargaining proposal pursuant to the public notice requirements of Government Code Section 3547 and the policies of this Board implementing that section.
- A person wishing to address the Board shall complete a written request to address the Board at the beginning of the meeting at which they wish to speak.
- The request shall include the person's name and name of the organization or group represented, if any, and a statement noting the agenda item or topic to be addressed.
- No member of the public may speak without being recognized by the President of the Board.
- Each speaker will be allowed a maximum of three minutes per topic. A total of 30 minutes shall be the maximum time allotment for public speakers on any one subject regardless of the number of speakers at any one board meeting. At the discretion of a majority of the Board, these time limits may be extended.
- Each speaker coming before the Board is limited to one presentation per specific agenda item before the Board, and to one presentation per meeting on non-agenda matters.

BP 2355 Decorum - BP9014.2

Legal References:

Education Code Section 72121.5; Government Code Section 54954.3 (b)

The following will be ruled out of order by the presiding officer:

- Remarks or discussion in public meetings on charges or complaints which the Board has scheduled to consider in closed session.
- Profanity, obscenity and other offensive language.
- Physical violence and/or threats of physical violence directed towards any person or property.

In the event that any meeting is willfully interrupted by the actions of one or more persons so as to render the orderly conduct of the meeting unfeasible, the person(s) may be removed from the meeting room.

Signs, placards or other items that create noise or cause an obstruction of view that constitutes or would constitute a persistent disruption of the proceedings will not be permitted.

Speakers who engage in such conduct may be removed from the podium and denied the opportunity to speak to the Board for the duration of the meeting.

Before removal, a warning and a request that the person(s) curtail the disruptive activity will be made by the President of the Board. If the behavior continues, the person(s) may be removed by a vote of the Board, based on a finding that the person is violating this policy, and that such activity is intentional and has substantially impaired the conduct of the meeting.

If order cannot be restored by the removal in accordance with these rules of individuals who are willfully interrupting the meeting, the Board may order the meeting room cleared and may continue in session. The Board shall only consider matters appearing on the agenda. Representatives of the press or other news media, except those participating in the disturbance, shall be allowed to attend any session held pursuant to this rule.

If requested, the minutes shall be made available in appropriate alternative formats so as to be accessible to persons with a disability.

BP 2365 Recording (new)

If the Board causes any tape or video recording of a meeting, the recording shall be subject to inspection by members of the public in accordance with the California Public Records Act, Government Code Sections 6250 et seq. The Chancellor is directed to enact administrative procedures to ensure that any such recordings are maintained for at least thirty days following the taping or recording.

Persons attending an open and public meeting of the Board may, at their own expense, record the proceedings with an audio or video tape recording or a still or motion picture camera or may broadcast the proceedings. However, if the Board finds by a majority vote that the recording or broadcast cannot continue without noise, illumination, or obstruction of view that constitutes or would constitute a persistent disruption of the proceedings, any such person shall be directed by the President of the Board to stop.

Legal-Reference:

Education Code Section 70902; Accreditation Standard IV.B.1.b & e; Title 5 sections 51023.5-51023.7 and 53200-53204

The Board may adopt such policies as are authorized by law or determined by the Board to be necessary for the efficient operation of the District. Board policies are intended to be statements of intent by the Board on a specific issue within its subject matter jurisdiction.

The policies have been written to be consistent with provisions of law, but do not encompass all laws relating to district activities. All district employees are expected to know of and observe all provisions of law pertinent to their job responsibilities.

Policies of the Board may be adopted, revised, added to or amended at any regular board meeting by a majority vote in accordance with the provision of Board Policy 9023. Any adoption and/or approval of new Board policies or changes to existing Board policies must take place as part of a two meeting approval process. The first meeting will be considered the "FIRST READING, INFORMATION ONLY" of the policy or change to existing policy for the purpose of review, questions and answers, and other considerations of the recommendation. At the second meeting, it will be considered the "SECOND READING, ACTION ITEM."

The Board will consider the item for action, which may have been modified at either the first or second reading. If the modification at the second reading is major, as determined by the Board, such a reading will be termed a first reading and introduced at a subsequent Board meeting as a second reading.

The RSCCD Board of Trustees believes that a major trustee role is to set policy for the District. In setting policy, the Board wants to create and work within a participatory environment with respect for students and all employee groups. For developing policies regarding the academic and professional matters numbered 1, 2, 3, 5, and 8, the Board will consult collegially with the faculty by relying primarily on the advice and judgment of the Academic Senate (per previous agreement with the Senate).*

For developing policy regarding the other five academic and professional matters, the Board will consult with the faculty through the mutual agreement process previously agreed upon. At RSCCD, the mutual agreement process is the use of the shared governance structure consisting of councils, committees, and the District Council. Further, representatives of staff and student groups are encouraged to work within the established processes to address the issues of the District.

The Board of Trustees values consensus building; however, it realizes its legal responsibility to make final decisions regarding policy.

*For the following items the Board of Trustees will rely primarily upon the advice of the Academic Senate:

1) Curriculum, including establishing prerequisites and placing courses within disciplines; 2) Degree and certificate requirements; 3) Grading policies; 5) Standard or policies regarding student preparation and success; 8) Policies for faculty professional development activities;

For the following items, the Board of Trustees will come to mutual agreement with the Academic Senate:

- 4) Educational program development; 6) District and college governance structures, as related to faculty roles; 7) Faculty roles and involvement in accreditation processes, including self study and annual reports;
- 9) Processes for program review; 10) Processes for institutional planning and budget development.

Administrative regulations are to be issued by the Chancellor as statements of method to be used in implementing Board Policy. Such administrative regulations shall be consistent with the intent of Board Policy. Administrative regulations may be revised as deemed necessary by the Chancellor. The Board reserves the right to direct revisions of the administrative procedures should they, in the Board's judgment, be inconsistent with the Board's own policies.

Copies of all policies and administrative procedures shall be readily available to District employees through the District website.

The Board delegates to the Chancellor the executive responsibility for administering the policies adopted by the Board and executing all decisions of the Board requiring administrative action.

The Chancellor may delegate any powers and duties entrusted to him or her by the Board, but will be specifically responsible to the Board for the execution of such delegated powers and duties.

The Chancellor is empowered to reasonably interpret board policy. In situations where there is no board policy direction, the Chancellor shall have the power to act, but such decisions shall be subject to review by the Board. It is the duty of the Chancellor to inform the Board of such action and to recommend written board policy if one is required.

The Chancellor is expected to perform the duties contained in the Chancellor job description and fulfill other responsibilities as may be determined in annual goal-setting or evaluation sessions. The job description and goals and objectives for performance shall be developed by the Board in consultation with the Chancellor.

The Chancellor shall ensure that all relevant laws and regulations are complied with, and that required reports are submitted in timely fashion.

The Chancellor shall make available any information or give any report requested by the Board as a whole. Individual trustee requests for information shall be met if, in the opinion of the Chancellor, they are not unduly burdensome or disruptive to District operations. Information provided to any trustee shall be available to all trustees.

The Chancellor shall act as the professional advisor to the Board in policy formation.

All reports, recommendations, and correspondence to the Board of Trustees from any employee shall be submitted to the chancellor for transmittal to the Board.

The chancellor or representative shall have the privilege of attending all meetings of the Board and its committees with the right to speak on all matters under discussion.

The chancellor shall have such other powers and duties as may be approved by the Board of Trustees in order to fulfill the functions of office.

The Board delegates authority to the Chancellor to appoint an acting Chancellor to serve in his or her absence.

In the absence of the Chancellor and when an acting Chancellor has not been named, administrative responsibility shall reside with (in order):

- Executive Vice Chancellor, Human Resources & Educational Services
- Vice Chancellor, Business Operations & Fiscal Services
- President, Santa Ana College
- President, Santiago Canyon College

The Board shall appoint an interim Chancellor whenever the position is vacant.

In early December June of each year, the chair President of the Board of Trustees will schedule a meeting with the chancellor to discuss the chancellor's evaluation process.

Following that meeting, the <u>chair President</u> of the Board will indicate to the Board of Trustees in closed session that he/she has completed the scheduled conference with the chancellor.

The chancellor will prepare a self-evaluation to include progress toward achieving annual goals and long-range goals and other materials as appropriate. The self-evaluation will be available to all Board members at least two days prior to the evaluation session.

The evaluation session will be posted as required by California Code.

The Board of Trustees may opt to hold the scheduled evaluations with the chancellor present at the session, with the chancellor not present at the session, or with any combination it deems necessary.

Following the evaluation, the <u>chair President</u> of the Board of Trustees will present the results of the formal evaluation to the chancellor in writing.

The contents of the evaluation will be kept confidential unless the chancellor determines a need to discuss said content in order to address issues that have been indicated for action.

The Board shall conduct an evaluation of the Chancellor at least annually. Such evaluation shall comply with any requirements set forth in the contract of employment with the Chancellor as well as this policy. The Board shall evaluate the Chancellor using an evaluation process developed and jointly agreed to by the Board and the Chancellor. The criteria for evaluation shall be based on Board policy the Chancellor's job description, and performance goals and objectives developed in accordance with BP 2430 titled Delegation of Authority to the Chancellor.

The Board is the ultimate decision-maker in those areas assigned to it by state and federal laws and regulations. In executing that responsibility, the Board is committed to its obligation to ensure that appropriate members of the District participate in developing recommended policies for board action and administrative procedures for Chancellor action under which the District is governed and administered.

Each of the following shall participate as required by law in the decision-making processes of the district:

Academic Senate(s) (Title 5, Sections 53200-53206.)

The Board or its designees will consult collegially with the Academic Senate, as duly constituted with respect to academic and professional matters, as defined by law and specified in Board Policy 9001.

Staff (Title 5, Section 51023.5.)

Staff shall be provided with opportunities to participate in the formulation and development of district policies and procedures that have a significant effect on staff. The opinions and recommendations of recognized classified and management organizations will be given every reasonable consideration.

Students (Title 5, Section 51023.7.)

The Associated Student Governments shall be given an opportunity to participate effectively in the formulation and development of district policies and procedures that have a significant effect on students, as defined by law. The recommendations and positions of the Associated Student Governments will be given every reasonable consideration. The selection of student representatives to serve on district committees or task forces shall be made after consultation with the Associated Student Governments.

Except for unforeseeable emergency situations, the Board shall not take any action on matters subject to this policy until the appropriate constituent group or groups have been provided the opportunity to participate.

Nothing in this policy will be construed to interfere with the formation or administration of employee organizations or with the exercise of rights guaranteed under the Educational Employment Relations Act, Government Code Sections 3540, et seq.

Collective bargaining begins when either an exclusive representative or the District itself presents an initial proposal for consideration in accordance with the timelines established in the district's collective bargaining agreements .

A board member shall not be considered to be financially interested in a contract if his or her interest is limited to those interests defined as remote under Government Code Section 1091 or is limited to interests defined by Government Code Section 1091.5.

A board member who has a remote interest in any contract considered by the Board shall disclose his or her interest during a board meeting and have the disclosure noted in the official board minutes. The board member shall not vote or debate on the matter or attempt to influence any other board member to enter into the contract.

A board member shall not engage in any employment or activity that is inconsistent with, incompatible with, in conflict with or inimical to his or her duties as an officer of the district.

In compliance with law and regulation, the Chancellor shall establish administrative procedures to provide for disclosure of assets of income of board members who may be affected by their official actions, and prevent members from making or participating in the making of board decisions which may foreseeably have a material effect on their financial interest.

Board members shall file statements of economic interest with the filing officer identified by the administrative procedures.

Board members are encouraged to confer with the Board President in every case where any question arises regarding a potential conflict of interest. The Board President and Chancellor may seek counsel from the District's legal advisor if necessary.

It is the policy of the Board to comply with the terms of Title 2 California Code of Regulations, Section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission.

Board members and designated employees shall file statements of economic interests with the Chancellor or designee, who will make public, file and disseminate the statements according to government codes and local requirements. The Chancellor will maintain an administrative regulation identifying its procedures for such statements and the designations for employees.

Board members and designated employees shall not be financially interested in any contract made by the Board or in any contract they make in their capacity as board members.

Board members and designated employees shall not be considered to be financially interested in contract if his or her interest is limited to those interests defined as remote under Government Code Section 1091 or is limited to interests defined by Government Code Section 1091.5.

Board members who have a remote interest in any contract considered by the Board shall disclose his or her interest during a board meeting and have the disclosure noted in the official board minutes. The board member shall not vote or debate on the matter or attempt to influence any other board member to enter into the contract.

Board members and designated employees shall not engage in any employment or activity that is inconsistent with, incompatible with, or in conflict with or inimical to his or her duties as an officer of the district.

A Board member shall not simultaneously hold two public offices that are incompatible.

Upon leaving the Board, former members shall not, for a period of one year act as an attorney, agent, or otherwise represent for compensation others appearing before the Board.

The Board of Trustees prohibits the District from conducting any business for compensation with a former trustee for one year from the date of leaving office.

All Rancho Santiago Community College District board members are committed to maintaining the highest standards of conduct and ethical behavior. The Board believes that in promoting trust, confidence, and integrity in the working relationship between Trustees, administrators, faculty and Staff. The Board and its individual Trustees are committed to the following:

- In all decisions the Board will consider the educational welfare and equality of opportunity of all students in the District.
- Trustees are elected to represent the interests and serve the needs of the entire District and to promote the mission of Rancho Santiago Community College District.
- Trustees are non-partisan elected officials and will always put District and college priorities before their own political or personal priorities.
- Trustees hold a public trust that requires and will ensure that their actions avoid conflicts of interest and any appearance of impropriety.
- Trustees will speak on behalf of the Board only when granted such authority by a majority of the Board.
- Trustees shall be respectful of others in any discussions related to the district and colleges.
- Trustees clearly articulate to the Chancellor the Board's expectations, will support the work and
 efforts of the Chancellor, and keep the Chancellor informed of matters related to the district and
 colleges.
- Trustees will respect the confidentiality of all privileged information.

- Trustees will uphold the letter and spirit of the Ralph M. Brown Act and make all official decisions and actions of the Board of Trustees in open and public meetings.
- Trustees will remain informed about the district, educational issues, and responsibilities of trusteeship, and will work in the best interest of the entire district.

The President of the Board, in consultation with the Chancellor, is authorized to consult with legal counsel when they become aware of or are informed about actual or perceived violations of pertinent laws and regulations, including but not limited to conflict of interest, open and public meetings, confidentiality of closed session information, and use of public resources. Violations of law may be referred to the District Attorney or Attorney General as provided for in law.

Violations of the board's policy code of ethics will be addressed by the President of the Board, who will first discuss the violation with the trustee to reach a resolution. If resolution is not achieved and further action is deemed necessary, the president may appoint an ad hoc committee to examine the matter and recommend further courses of action to the board. Sanctions will be determined by the board officers and may include a recommendation to the board to censure of the trustee. If the President of the Board is perceived to have violated the code, the vice president of the board is authorized to pursue resolution.

The Board of Trustees of the Rancho Santiago Community College District shall abide by all State laws, Education and Government codes relating to political activities and solicitation of political contributions.

Six months prior to every general election, the Board will seek college counsel to provide the latest legal status of laws and regulations relating to solicitation of political contributions and political activities by Board members, officers, and employees of the college. This status report will be distributed to all Board members and employees groups.

Members of the Board shall not use District funds, services, communication resources, supplies, or equipment to urge the passage or defeat of any ballot measure or candidate, including, but not limited to, any candidate for election to the governing board.

Initiative or referendum measures may be drafted on an area of legitimate interest to the district. The Board may by resolution express the Board's position on ballot measures. Public resources may be used only for informational efforts regarding ballot measures.

This policy shall not be construed as preventing an employee or official of the District from engaging in separate conversations or communications with members of the Board outside of a meeting in order to answer questions or provide information regarding a matter that is within the subject matter jurisdiction of Board, if that person does not communicate to members of the Board the comments or position of any other member or members of the Board.

BP 2725 Board Member Compensation (new)

Members of the Board, including the student member, who attend all board meetings shall receive \$750 per month. The board may reduce that amount by resolution. A member of the Board who does not attend all meetings held by the Board in any month shall receive, as compensation, an amount not greater than the pro rata share of the number of meetings actually attended.

A member of the Board may be paid for a meeting when absent if the Board, by resolution, finds that at the time of the meeting the member is performing services outside the meeting for the community college district, is ill, on jury duty, or the absence is due to a hardship deemed acceptable by the Board. However, after two absences in a calendar year, compensation will only occur by a unanimous vote of the Board.

The Board may, on an annual basis, increase the compensation of Board members by five percent. However, any increase is subject to rejection in a referendum by a majority of the voters in the District.

Eligibility

In accordance with Sections 53201, 53205 of the Government Code, all active members of the Board of Trustees excluding the student representative, are eligible for participation in the district's group medical-dental plan.

Benefits

The district will pay the insurance premium for medical-dental coverage of eligible trustees and their eligible dependents.

Retired/Inactive Trustees

For Board members elected to a term of office before January 1, 1995, and who have served 12 years and one day as a Board member and subsequently resigns, retires, or is not re-elected to the Board, the member is to continue coverage under the district's group medical-dental insurance plans. The district will continue to pay the premium for the Board member and dependents. Surviving dependent spousal benefits will continue.

For Board members first elected to a term of office that beings after January 1, 1995, the above provision for retired/inactive Board members is not applicable based upon Government Code 53201(c). Retirees/inactive members may purchase the district's group medical-dental insurance plans at their own expense.

Members of the Board shall be permitted to participate in the District's health benefit programs. The benefits of members of the Board through the District's health benefits programs shall not be greater than the most generous schedule of benefits being received by any category of non-safety employee of the District.

Former members of the Board may continue to participate in the District's health benefits programs upon leaving the Board if the following criteria are met: the member must have begun service on the Board after January 1, 1981; the member must have been first elected to the Board before January 1, 1995; and the member must have served at least 12 years. All other former Board members may continue to participate in the District's health benefits programs on a self-pay basis.

Members of the Board shall have travel expenses reimbursed whenever they travel as representatives of and perform services directed by the Board. Such board travel and reimbursement for travel by Board members outside of the district boundaries must receive prior approval from the Board of Trustees. The Executive Committee of the Board of Trustees, in consultation with the Chancellor, may provide prior authorization for such travel when needed, pending full Board approval. Standard district travel procedures and rates will be used for reimbursement. (See AR 4108.)

The Board President, in conjunction with the Chancellor, will prepare a list of conferences and legislative executive visits that Board members may wish to attend or will assist Board members in their continuing education and fulfillment toward the mission of the district. The Chancellor, in consultation with the Board President, shall prepare a budget for board travel.

Effective and efficient governing board operations are an integral part of sound policy making and broad oversight that lead to successful educational programs and student learning outcomes. The board is committed to assessing its own performance as a board in order to identify its strengths and areas in which it may improve its functioning in carrying out its responsibilities to the citizens of the Rancho Santiago Community College District.

For its self-evaluation the board shall be evaluated as a whole and not as individuals. The evaluation will focus on the internal board operations and performance. Board members shall develop goals which will be used in the self-evaluation process. A self-evaluation instrument will be based on these goals and not goals set for the district. The self-evaluation process shall include the establishment of strategies for improving board performance. Policies and goals will be reviewed and updated for the following year's self-evaluation. The student trustee will participate in the self-evaluation process.

No later than the end of September of every year the Board Policy Committee shall recommend to the full board a self-evaluation instrument and process to be used in board self-evaluation, as well as any changes to the list of individuals who will receive a copy of the instrument. The board shall promptly review and act on these recommendations. Any self-evaluation instrument shall incorporate criteria contained in these board policies regarding board operations, criteria defining board effectiveness as defined by recognized practitioners in the field and any other criteria the board determines would enhance the goal of identifying the board's strengths and areas in which it might improve its functioning.

The board is committed to having an annual self-evaluation meeting no later than November, at a date selected at the board's annual organizational meeting. All trustees will attend this self-evaluation meeting which will be open to the public, and district students, employees, and residents will be encouraged to attend and provide input to the board at the meeting.

Board members will be given the self-evaluation instrument prior to the annual self-evaluation meeting but shall not complete the self-evaluation instrument until after the meeting. The completed and signed instrument shall be submitted to an office designated by the Board President. The results will be tabulated and discussed at the next board meeting. The results will be widely communicated and maintained in the district office. The results will be used to identify accomplishments in the past year and goals for the following year that will be reviewed and updated annually.

Some district students, employees, and residents will, because of their position or regular attendance at board meetings, have some familiarity with internal board operations and performance so as to provide meaningful input to the board in their self-evaluation process. Therefore, prior to the board's self-evaluation meeting, the board shall make available the self-evaluation instrument to a list of individuals which will include but not be limited to the associated student government presidents, presidents of the academic senates, the college presidents, the chancellor, vice chancellors, representatives of the district's employee unions, and community members who serve on the district bond oversight committees or foundations. Any input from these individuals shall be given and reviewed at the self-evaluation meeting.

In addition, any student, community member, or employee shall be entitled to provide input to the board at the board's self-evaluation meeting.

BP 2750 Board Member Absence from the State

Government Code Section 1064

No member of the Board shall be absent from the state for more than 60 days, except in any of the following situations:

- Upon business of community college district with the approval of the Board.
- With the consent of the Board for an additional period not to exceed a total absence of 90 days. In the case of illness or other urgent necessity, and upon a proper showing thereof, the time limited for absence from the state may be extended by the Board.
- For federal military deployment, not to exceed an absence of a total of six months, as a member of the Armed Forces of the United States or the California National Guard. If the absence of a member of the Board pursuant to this subdivision exceeds six months, the Board may approve an additional six-month absence upon a showing that there is a reasonable expectation that the member will return within the second six-month period, and the Board may appoint an interim member to serve in his/her absence. If two or more members of the Board are absent by reason of the circumstances described in this subdivision, and those absences result in the inability to establish a quorum at a regular meeting, the Board may immediately appoint one or more interim members as necessary to enable the Board to conduct business and discharge its responsibilities.
- The term of an interim member of the Board appointed as set forth above may not extend beyond the return of the absent member, nor may it extend beyond the next regularly scheduled election for that office.

Discussion and Debate - BP9019

Limitations on Discussion and Debate

- 1.—Except as expressly authorized by the Ralph M. Brown Act, no action or discussion shall be undertaken on any item not appearing on the posted agenda.
- 2.—Each member of the Board has the right to speak to every debatable motion before it is finally acted upon.
- 3. When a member has begun to speak in debate, the member cannot be interrupted by another member or by the chair except for one of the following purposes, and then only when the urgency of the situation justifies it:
- a. A call for the orders of the day.
- b. The raining of question of privilege.
- c. A point of order.
- d. A call for a separate vote on one or more of a set of independent resolutions on different subjects that have been offered by a single motion.
- e. A request or inquiry that requires an immediate response.
- f. An appeal.
- g. An objection to the consideration of a question.
- h. A division of the Board.

Decorum in Debate

Debate must be confined to the merits of the pending question. Members should maintain a courteous tone, and avoid injecting a personal note into debate. To this end, members must never attack or make any allusion to the motives of members.

Alcohol Consumption - BP9021

Adopted 01/11/93

The Board of Trustees of the Rancho Santiago Community College District, having full legal authority and responsibility for the district, is committed to maintaining the highest standards of trusteeship and to preserving the integrity of the institution.

In conducting the business of the district, the Board of Trustees occasionally meets off campus at hotels or restaurants where alcohol is served. It is necessary, therefore, for the Board of Trustees to set policy which clearly defines its position on alcohol consumption. The Board and each of its individual members shall abide by the following edicts:

- 1.—It is the policy of this Board that no alcohol will be consumed by any member of the Board of Trustees at any official meeting where the business of the district is being conducted.
- 2.—It is also the policy of this Board that no public funds will be used to cover the cost of alcohol consumption at any meeting of the Board for any reason.

BP 2746 Board of Trustees Annual Evaluation of District Goals — BP9022.5

The board recognizes that it can better perform its policy making and broad oversight roles if it annually reviews the district's goals in addition to its own internal board operation and performance goals. Therefore, separate from the annual self-evaluation meeting, the Board President, with the assistance of the Chancellor or third party will develop a survey instrument to members of the District Citizens' Advisory Committee; District Bond Oversight Committee; local Chambers of Commerce and trade unions; community organizations; college and district foundations; federal, state, county and local elected officials who represent parts of the district; city and school district managers and superintendents; and others whom the board may feel can provide important feedback to the board. In addition, all district employees and students will be encouraged to respond to this survey instrument. The Board President shall work with the chancellor or third party to ensure the information from the survey instrument is collected.

The board will then schedule an annual meeting at a time to maximize coordination with the planning process of the district administration and colleges, to discuss district goals and use the results of the survey and any information received at the annual meeting to assist the board in assessing the areas where the district goals have been met or exceeded and those areas where improvement was needed. District goals and policies will be updated or revised as a result of the information obtained in this process. Any student, employee, or resident of the district shall also have the opportunity to attend this public meeting to provide input to the board. The results of the survey will be widely distributed and will be maintained at the district office.
