Board of Trustees (Regular meeting) March 13, 2017

MINUTES

1.0 PROCEDURAL MATTERS

1.1 Call to Order

The meeting was called to order at 4:38 p.m. by Mr. John Hanna. Other members present were Ms. Claudia Alvarez, Ms. Arianna Barrios, Mr. Zeke Hernandez, Mr. Larry Labrado, Ms. Nelida Mendoza, and Mr. Phillip Yarbrough. Ms. Esther Chian was not present due to being out-of-state on student business.

Administrators present during the regular meeting were Ms. Judy Chitlik, Mr. Peter Hardash, Dr. John Hernandez, Mr. Enrique Perez, Dr. Raúl Rodríguez, and Dr. Linda Rose. Ms. Anita Lucarelli was present as record keeper.

Mr. Hanna asked for a moment of silence for prayer or contemplation to remember all the members of the armed services who have given their lives for our country and all the RSCCD students who work hard every day for themselves and their families.

Mr. Hernandez reported that he attended a new board member reception and dinner meeting for the Orange County School Boards Association on March 1, 2017.

Mr. Hernandez reported that he attended a musical performance (Sound of Music) at Godinez Fundamental High School recently that included Mr. Phillip Pacier, SCC faculty member, as a member of the live band that performed. Ms. Mendoza reported she attended the musical also and commended the students on their performance. She asked if a partnership could be cultivated with local high school districts to use SAC Phillips Hall or SCC's performing arts center for performances.

Mr. Hernandez reported that while in Washington, D.C., he extended an invitation to Ms. Betsy DeVos, the United States Secretary of Education, to visit SAC; and he mentioned the possibility of the California Board of Governors holding an upcoming meeting.

Mr. Yarbrough reported that he received a lot of feedback on the editorial that he wrote regarding DACA students and he thanked Dr. Sara Lundquist for the helpful information she provided. While in Washington, D.C., he indicated that legislators expressed interest in protecting DACA students.

Mr. Yarbrough asked for the district's policy on the use of marijuana since he received a call from an *el Don* student reporter asking for information on this subject. He indicated that if the district doesn't have a policy, perhaps the Board Policy Committee should consider creating one.

Mr. Hanna and Ms. Alvarez congratulated the women honored for Women's History Month earlier in the board meeting. Mr. Hanna expressed appreciation for the three women currently serving as trustees for the district.

Ms. Alvarez and Ms. Mendoza commended everyone who made the immigration forum meeting at Centennial Education Center a success on March 10, 2017. Ms. Alvarez indicated there were 200 people present and 400 people following the forum on Facebook Live. Ms. Alvarez asked that translation equipment be provided in order to make the forums flow in a more timely manner.

Ms. Mendoza assured faculty that the board appreciates RSCCD faculty members, staff, and students.
