



*3.3 Approval of Addendum to the VitaNavis Subscription Agreement-Renewal between The Myers-Briggs Company and Rancho Santiago Community

College District on behalf of Santa Ana College.

The administration recommends approval of the addendum to the VitaNavis subscription agreement-renewal between The Myers-Briggs Company and RSCCD on behalf of SAC, as presented.

I would ask if additional information can be provided at meeting on the assessments provided to students - to get a more thorough understanding of its relationship and support to Guided Pathways. I am guessing that this is Year 3 of a five-year agreement.

- Guided Pathways is a structured framework to increase student's success and provides clear pathways, and integrates support services.
- The SuperStrong Interest Inventory (SSII) is a condensed version of the Strong Interest Inventory (SII), which is used in the onboarding process of Santa Ana Unified School District seniors and new students to the college.
- High school seniors will be administered the SuperStrong Interest Inventory to inform their decision making and selection of the Career and Academic Pathways (CAPs) found on the Santa Ana College application for admissions.
- The SuperStrong is a tool that will help students understand their interests and work styles.
- The SuperStrong will help students identify a possible major leading to their ideal career pathway.
- The SuperStrong will provide students with information about career outlook, growth, and income information.
- The SuperStrong results are personalized to the Career and Academic Pathway options available at SAC.
- The previous agreement was for two years. This agreement renewal is for one year.
